Barstow City Council Votes To Bar Mayor Courtney From City Hall

Based upon the preliminary findings of an investigation, internal Mayor Paul Anthony Courtney has been temporarily barred from having direct access with anyone at City Hall other than City Manager Willie Hopkins.

By a 4-to-0 vote of the city council during a closed session of the city council Monday night, September 12, a decision to end Courtney's privileges as an elected

official at City Hall was made. His office was sealed off and his key and passcode disabled.

No authorized state-

ment regarding that action has been publicly made, although a written statement was, according to an employee within the city manager's office, under preparation on Tuesday. That statement has yet to be provided to the press or public. The city attorney is to make a public report of the situation at the next meeting of the city council. More than eight months ago, on December 21, 2021, the Barstow City

Council voted to censure Courtney, making an expression of disapproval for what its members said was Courtney's use of his mayoral status and the city's name and logo to engage in what was characterized as a political mailing camouflaged as an official handbill aimed at promoting the city but which Courtney's critics maintained was intended to advance himself politically. He was further charged with

overstepping his reach as mayor in effectuating official action.

Information as to what was examined in the most recent investigation of the mayor is being closely guarded by the city.

The agenda for the specially-called meeting did not explicitly state nor offer any indication that action against the mayor was being contemplated.

\$446,000 In Legal Work Later, Mayor Valdivia And His Lawyer Pacheco Part Company

The relationship between lame duck San Bernardino Mayor John Valdivia and Rod Pacheco, the attorney who defended him so passionately against a bevy of lawsuits and accusations of sexual harassment, abuse of his official authority and political corruption, has apparently gone south.

Pacheco, who a generation ago waged a bat-

tle to establish a niche for Hispanic politicians within the Republican Party, is credited by some with having created or at least partially created the atmosphere within which Valdivia was able to establish what just a few years ago appeared to be a promising political presence as arguably one of the more significant Latino officeholders in San Bernardino County.

A San Bernardino native who went onto a successful legal career, initially as a deputy prosecutor in the Riverside County District Attornev's Office, Pacheco in 1996 was elected to the California Assembly. In November 1998 he was chosen by his colleagues as the Republican Assembly leader, marking the first time in the state's history that a Latino had served in that capacity. He narrowly missed out on becoming assembly speaker as a consequence of the Republicans having lost a net five Assembly seats in that month's election rather than picking up two seats as had been the GOP's hope going into that election cycle. In 2002, he was termed out of the Assembly and went back to being a lawyer. In 2006, he was elected Riverside County District Attorney, serving a single term in that role.

Valdivia was first elected to the San Bernardino City Council 2011, representing that city's Third Ward. In 2014, he flirted with a run for Congress in California 31st Congressional District, but ultimately decided against doing so because he and his political handlers recognized that to See P 4

Tropical Storm Kay Deluge Wreaks Havoc & Death In The Southeast San Bernardino Mountains

The flooding and severe mud flows in Forest Falls, Oak Glen and other spots around the San Bernardino Mountains that followed in the wake of Tropical Storm Kay on Monday, September 12 have claimed at least one life and prompted the county to declare a state of emergency.

While excessive sheetflow was general all over the south central area of the county, the burn areas created by 2020's Apple and El Dorado fires experienced a rapid accumulation of water that contributed to a flash flood circum-

In Forest Falls, power was knocked out early and no one was able to get in or out of the area as the deluge began and authorities advised residents caught there to

hunker down, as it was deemed too dangerous to brave the intense flows across Valley of the Falls Drive. Debris and mud flows rushing down the natural drainages and creek beds proved an overwhelming force throughout Forest Falls. As the Lower Canyon was threatened by both cascading water and mud flows, an evacuation order for Forest Falls from Canyon Drive to Prospect Drive was given, followed by another.

Ultimately mudslides destroyed or severely damaged at least 30 homes in the area, in at least two cases moving houses off their foundations. By Tuesday there were reports of six missing persons.

Intensive searches mounted, spite the conditions. By

agenda were three items, those being "Conference with legal counsel – initiation of litigation" [and] "Conference with legal counsel – anticipated litigation" [and] "Labor negotiations – (Government Code Section 54957.6) public employees."

the section Under referencing anticipated litigation, the agenda stated, "A point has been reached where, in the opinion of the city council on the advice of its legal counsel, based on the below described existing facts and circumstances, there is a significant exposure to litigation against the city. Facts and circumstances that might result in litigation but which the city believes are not yet known to potential plaintiffs."

There is a slight discrepancy with regard to the timing of the actions taken by the city and city council as well as the availability of the information upon which those decisions were based.

In the public comment section of the specially-called meeting Monday night, resident Mike Hernandez importuned the council to make public the findings of what has been represented as a "third-party" investigation of the mayor.

"The taxpayers paid for this, and they have a right to know what's in it," Hernandez said.

Hernandez also suggested it was a foregone conclusion that the mayor had engaged in the action his critics accuse him of, in particular threatening or intimidating city staff. He suggested the council had been remiss in protecting city staff and holding Courtney accountable.

This provoked a response from Councilman Tim Silva, made before

the council went into its closed session, which suggested the action the council was to take had already been taken or that the outcome of the meeting was known in advance.

Silva said, "We did take action to keep the mayor from talking directly to city employees, all communication to city employees. The council vote, 4-0, is to go through the city manager. That was an action to protect city employees, so to say we did nothing to protect city employees is totally false."

Councilwoman Barbara Rose doubled down on that assertion, saying, "We have taken multiple actions to protect our city staff employees, our city manager and the general public. We have shown over and over again at multiple meetings what stand we are taking. I wish we didn't have to go that route, but the mayor has put us in no other position than to take that route, and so we are holding him accountable and [bv] a third-party investigation and [with] any other investigations that are coming forward or lawsuits, we will continue to take those very seriously and do our due diligence and protect the city and the stakehold-

Also speaking before the council went into closed session Monday night was John Williams.

Addressing Courtney, Williams said, "You've put the city in a bad position. You said, 'A better Barstow.' What we're getting is a bad Barstow. With your lawsuits, with your third-party investigation, and maybe another lawsuit if you sue the city, what are you doing? You just can't stop, can you? We're here tonight, for you. We're going to be here for a long time tonight after you leave, because of you. This is the mayor of Barstow doing these things. No wonder we're in trouble and we're going to continue being in trouble, and there's going to continue to be more lawsuits coming. Just step down. Go do your thing. Live your life and save the city of Barstow, because

what you're doing to the town you say you love, you're destroying that. It is unbelievable where you went with this thing. I'm embarrassed for you. And I'm going to tell you, you're a good man. You really are. You really do good things, but you just cannot do it. And then you've got puppets around you, and you rip that string up and the hand goes flying up in the air. It's embarrassing. And everyone up there is allowing this to happen. It's shameful."

At 5:13 p.m., which was 18 minutes and 13 seconds into the 31 minutes-and-three secondslong broadcast of the proceedings, the council adjourned into a closed session.

Initially, during the remaining portion of the broadcast, a static image was displayed on the viewing screen, which said, "City council closed session in process."

The expectation of many was that the council would come out of the closed session, at which point a report of the action taken would be made. At a point 25 minutes 48 seconds into the meeting, however, a static image with the statement "Meeting is

adjourned" was visible on the screen.

San Bernardino County Sentinel

At 26 minutes and two seconds into the broadcast, a final static image was being displayed, stating "Report out of closed session will occur at the city council meeting on September 19th."

The *Sentinel* learned of what had occurred when it was contacted by a city employee on Tuesday morning.

Speaking for himself and other staff members, the employee told the Sentinel, "We're not surprised that Mayor Courtney treated city staff so badly. Based on his early actions as mayor in which he retaliated against key city officials, resulting in several lawsuits, our distinct impression of him is that he believes his power as mayor is absolute and beyond reproach. That was made apparent during the deliberations regarding his attempt to – with the apparent aid of the finance director - allegedly defraud the city of seven months' worth of travel expenses. It wasn't so much the amount of money the mayor wrongly claimed he was owed, but the fact that he blatantly ignored city policy in the way he applied for

the reimbursement and the way it was approved."

He added, with regard to Courtney, "The rules that everyone else must abide by don't apply to him. Especially, apparently, the rules pertaining to the treatment of city staff who, according to municipal code, come under the direct supervision of the city manager and not the city mayor."

Courtney told the Sentinel, "In a politically-motivated act intended to intimidate me personally and undermine my ability to fulfill my duties as the elected mayor of Barstow, I was stripped of my office at City Hall, and my ability to communicate with city staff

outside of the city manager, chief of police and fire chief. This is a political hit job. I have done nothing wrong and have been deprived of my lawful right to due process. The city refused to provide me notice of the allegations against me, has presented no evidence against me, and has not cited any lawful basis for these unprecedented acts against a duly elected mayor. It is clear that my political opponents will do anything to attempt to remove me rather than do what is best for Barstow. I intend to fight this unlawful action and am committed to serving the people."

house, Dutton served, essentially, as Brulte's surrogate, effectively extending the latter's tenure as a legislator not in name but in effect. Over the next eight years, Dutton followed Brulte's instructions and in 2010, under an arrangement engineered by Brulte, the Dutton assumed position of Republican Senate Leader, heading that 40-seat legislative body's 15-member GOP delegation.In 2012, at which point Dutton was termed out of the Senate, he sought but failed to win election to the U.S. Congress representing California's newly-drawn 31st Congressional District, capturing second place in that year's open primary among a field of four Democrats, himself and incumbent Republican Congressman Gary Miller. In that year's November general election, Miller handed Dutton the only defeat of his political career by a 55.18 percent-to-44.82 percent margin.

to-44.82 percent margin. considered Dutton running for San Bernardino County Supervisor in 2014, but having been burned in an effort to take on an incumbent and established Republican in the 2012 Congressional race convinced him he should not challenge Second District Supervisor Janice Rutherford, a member of the GOP. Instead, he ran to succeed Dennis Draeger, who was retiring that year as county assessor, which carried with it the duties of the county recorder and county clerk.

In the November general election against Tom Harp, the assistant assessor who had 34 years' experience in the assessor's office, Dutton prevailed by a slim 50.61 to 49.39 percent margin.

It took Dutton a bit of time to get his sea legs, but once he did, he set about in earnest in replicating the politicization of the assessor's office that had existed under Bill Postmus, who was Draeger's predecessor as assessor, and that of Gordon Young, who had been the assessor prior to the assessor Postmus had succeeded, Don Williamson. Postmus, who had once been chairman of the San Bernardino County Board of Supervisors and the chairman of the Republican Central Committee, used his position as assessor to set tax rates favorable to major donors to the Republican Party and the

county's Republican candidates, allowing those donors to be even more generous, and thereby structuring a way for Postmus to be a kingmaker who controlled who was elected to the county's most powerful political positions. In 2009, after less than three years as county assessor, Postmus imploded, and was eventually charged with and convicted on six political corruption charges relating to utilizing his position as assessor for political purposes after it was revealed that he had installed into 13 of the assessor's highest paying staff positions 11 individuals who had no experience in assessing or appraising property but were instead utilizing county facilities and equipment to engage in electioneering and partisan political activity.

"I have been active in our community for over a decade now," Jimenez said, "involved with different civic organization in the city. I understand how local government works and I'm ready to start working for our community on day one. We need to address the specific issues of District 1, such as development and fire protection in our foothills and lack of services in our parks, trails, and facilities."

Jimenez said, "I'm the only candidate with school age children,

I want to propose we use our parks, city facilities and recreational department to establish a city-run daycare center in every district of the city, for those folks that qualify in the middle-class category of \$50,000 to \$120,000 in household income per year."

He said, "I believe one of the biggest issues facing the city is the lack of good paying jobs in the city. Just like the rest of the Inland Empire, we have built way too many warehouses. Warehouse jobs do not pay the salaries necessary to afford a home in our city. Our residents must commute hours into L.A, Orange County, or other places to find those good paying jobs."

"That was my all-time favorite job-serving the emotional, spiritual, and often, physical needs of the citizens of Yucaipa. I now volunteer as a pastor since I recently began working in law enforcement advocacy."

Sahakian said, "I believe the major issues facing our city include ensuring the safety and security of our citizens. maintaining fiscally conservative decisionmaking, avoiding overdevelopment of our rural areas while still offering housing options to the community, and laying the groundwork for our next generation of citizens."

In delineating the action he believes the city needs to take to redress the issues facing it, Sahakian said, "If elected to the Yucaipa City Council my goals include: promoting local businesses by fostering a business-friendly, low tax environment; partnering with law enforcement and firefighters by

Consequently, Jimenez said, "We need to put a moratorium on building warehouses. We already have over 4,300 warehouses in our region alone. We need to support tech startups and other type of businesses that will pay those livable wages. We can attract those industries to our city if we create the right business climate for them."

According Jito menez, "We already have a lot of infrastructure; we have thousands of square footage in this massive warehouse in the southside of the city. We can change building codes so that those massive industrial buildings could be repurposed for other types of businesses, just like what they did with Haven City."

Jimenez freely acknowledged having no experience in government previously, which he said might be perceived as a recommendation of his candidacy rather than a shortcom-

run for the partisan post he would need to clearly demark himself as a Republican, which would potentially redound to his detriment in his efforts to remain on the city council or in a future run for mayor in San Bernardino, given the overwhelming Democrat-to-Republican voter registration advantage within the City of San Bernardino.

In 2015, Valdivia was reelected Third Ward councilman without opposition.

In 2018, he sought election as mayor, qualifying as the top vote-getter among seven candidates to compete in the runagainst incumbent Carey Davis, whom he beat in the November final, 19,155 votes or 52.5 percent to Davis's 17,327 votes or 47.5 percent.

Valdivia came into office in December 2018 with what appeared to be a commanding dominance of the city council, with only two of the panel's members set against him. In May 2019, when a special election was held to select his replacement as Third Ward councilman, his ally Juan Figueroa was elected to that post, such that it appeared Valdivia would have a ruling coalition on the seven-member council that was absolutely going to give him control over the city for the first two if not all four years of his term as mayor. Before 2019 had run its course, however, the San Bernardino scepter had slipped from his grip as he was pounded by one political scandal cascading into yet another political scandal followed by another political scandal and yet further scandal that ultimately undid him.

First, his chief of staff, Bill Essayli, left to take a position with an Orange County law firm. Then, one by one, as Valdivia pursued his own objectives, three of the memof his coalition Sandra Ibarra, Henry Nickel and Ted Sanchez - saw the political course the mayor was taking as averse to their own goals.

Moreover and more crucially, they grew to perceive that Valdivia was using their votes and support to construct quid pro quos with the clients of his consulting firm in which he was given money to deliver their votes in favor of those clients' business interests when the council was called upon to render decisions impacting those businesses. Ibarra, Nickel and Sanchez parted political company with him, such that he no longer had five reliable votes on the council but only two to support whatever he was attempting to achieve.

There followed a series of revelations: cannabis entrepreneurs came out of the woodwork, regaling newspaper reporters and the public with how he had promised marijuana operation licenses and permits to those who had applied for them in exchange for cash; an employee in his office, Mirna Cisneros, told of how he had made sexual advances to her and how he misused city funds to engage in travel and activity that had nothing to do with city business and was taking money from those with business before the city; another employee of the mayor's office, Karen Cervantes, related how the mayor had made sexual advances toward her; his field representative, Jackie Aboud, likewise said Valdivia had pressured her to accommodate his sexual needs; Alissa Payne, a single mother whom Valdivia appointed to two city commissions, said Valdivia had made similar indecent overtures to her; Valdivia's field representative Don Smith related how he had been present while Valdivia made a late night rendezvous with a city tow service franchise holder who handed Valdivia an envelope stuffed with cash; Matt Brown, who had succeeded Essayli as Valdivia's chief of staff, came forward to say that Valdivia attempted to have him make fraudulent

of Cisneros, Cervantes,

Aboud and Smith to justify their firings and discredit them with regard

Based on a host of Valdivia's actions, the city found itself facing nearly a dozen lawsuits.

With untoward accusations mounting, Valdivia continued to engage in questionable, bold and risky behaviors, utilizing city resources, funding and personnel to provide or defray the cost of providing materials and services relating to political promotions of himself and his associates while using city money to cover the cost of travel, meals and lodging while he was engaged in matters unrelated to his duty or function as mayor.

With legal challenges against him mounting, Valdivia created a fund, the Mayor John Valdivia Legal Defense Fund, which was separate from his existing political electioneering funds. He accepted direct donations into that legal defense fund and he also transferred money out of his electioneering accounts into the defense fund. He used the money in that defense fund to hire Pa-

In addition to asserting a defense in the face of the various lawsuits filed against Valdivia, Pacheco went on the public offensive on the mayor's behalf, propounding that Valdivia was an exemplary public servant who was being demonized by his political opponents.

According to Pacheco, Valdivia was a man of rectitude who was undeserving of the obloquy being heaped upon him. His client, Pacheco said, was an earnest public servant seeking to lead a city out of the financial doldrums it had been caught in, including the filing for bankruptcy protection the city had made in 2012, less than six months after Valdivia had been sworn in as Third Ward councilman. Pacheco imputed to several members of the city council political motives in the move to condemn the mayor with a censure vote it ultimately carried out in December 2021, and he harshly criticized the process as it was being conducted and overseen by the city's lawyers as one-sided and unfair. The former prosecutor accused the lawyer the city had hired to make the case for censure against Valdivia, Norma García Guillén, of misinterpreting the law or omitting facts and details to suit the case. Pacheco lampooned García Guillén as nothing more than a gun-for-hire who was serving as the city council's attack dog.

In a defense of Valdiv-

ia, Pacheco told the Sen-

tinel, "I grew up in San

Bernardino. I was raised

there. I moved there when

I was six. My father was in the Air Force and he was stationed at Norton Air Force Base. I went to college in San Diego, but I remained very close to San Bernardino. It was a wonderful city. It was called 'A City On The Move.' There was a lot going on in San Bernardino. It was the first city to have two malls. It was, then, a much better city than the one I live in now, Riverside. Now, they've flipped. That great city of my childhood has gone into the tank. It is very different now. Now you have a mayor, John Valdivia, who like former Mayor [Judith] Valles is trying to save it. The city has fallen into an abyss, and it is not a regular effort that is going to fix things. You are not going to turn things around working nine to five. It is going to require a Herculean effort. This is not the time for half measures. Public safety has become a real problem. For years, San Bernardino was the murder capital of California. San Bernardino has a lot of problems, and this mayor is ready to make a lot of extra effort. As mayor, John Valdivia has the desire to put forth that effort. He is a Type A person who wants to run the city right and he is demanding that people who work for him or work in the city do what they are being asked to do. That is the only way that things are going to be turned around. The hardest hit cities are the poorest cities. Rich people can sustain it or walk away and start over. The poor have the greatest difficulty, and San Bernardino is filled with the poor. It is really unfortunate that the one person in the city

working hardest to make a

change is now being subjected to this."

The city employees who had filed complaints naming Valdivia or had sued him, Pacheco said, were lazy and good for nothing. They resented Valdivia because he was the opposite of what they were: hard-working and dedicated.

"The city has really fallen apart and these people who have filed the complaints about having to work hard shouldn't be working for the city," Pacheco said. "They should go get a job where they can take it easy. What John Valdivia has taken on is a massive amount of work."

The reports that Valdivia is on the take and receiving bribes and kickbacks did not hold up, Pacheco said.

"I am familiar with those false allegations," Pacheco said. "They are abjectly false," Pacheco said.

Pacheco decried the "mob mentality" that had targeted the mayor. "You have members of the city council - some, not all of them - who have been very aggressive in attacking the mayor. I'm not sure what their motivation is. Maybe they think that this will make them look better in comparison to him. It may be political or it may be personal, but they are publicly stoking the flames based on falsehoods, saying the mayor should resign, trying to drive him out of office. It is ugliness. It is unfortunate. The city must be saved, and they are going after the one person who is committed to saving the city. I have watched the city's leadership since I was a kid. The one other mayor that was trying hard was Mayor Valles. And now the city has John Valdivia. They have not had true leadership in the city for a long, long time. Mayor [Robert] Holcomb presided over the glory days. When he left the city began to deteriorate slowly but surely over time."

Pacheco charged, "What is going on is the city council members are grabbing a hold of a false claim and running their mouths, saying, 'Well, the mayor needs to resign.' How dare they? Why don't they do their jobs for the people in the city?"

Accusations Valdivia has a problem with alcohol and with other intoxicants were, Pacheco said, "laughable." Pacheco similarly dismissed the sexual harassment charges leveled at Valdivia as hypercriticism of his having complimented a female employee on her choice of shoes.

There was a mercenary element to the false charges that were heaped on the mayor, Pacheco said. "They [the employees suing Valdivia] are trying to drive the city to pay them off," Pacheco said. "Some people will do anything for money. What was their motive in having a sequence of press conferences? Why not just have one press conference where they have their say? Why did they have four? Why were people who were not even government employees taking part?"

Pacheco continued, "They are trying to drive him out of office. I was hired to make sure he was treated fairly. There have been efforts to hamstring him from the beginning. He tried to hire an attorney, and the city wouldn't hire an attorney for him. They have not done anything to investigate this."

Documentation tained by the Sentinel shows that Valdivia made disbursements totaling \$446.762.45 from his legal defense fund to pay for Pacheco's services, including \$9,274.10 in 2020; \$386,354.25 in 2021 and \$51,134.10 in the first six months of 2022 ending on June 30.

Looking toward his 2022 election campaign, Valdivia created a political war chest titled John Valdivia For Mayor 2022. In 2021, he received donations of \$380,987.21 into that account. In the first five months of 2022, he received another \$106,500 into that account for a total over 18 months of \$487,487.21. Over the first three-anda-half years that he was mayor, Valdivia collected \$854,626.21 into his mayoral electioneering fund.

In 2021, he expended \$136,367.04 in preparing for his 2022 campaign. In 2022, from January through to the end of June, he spent \$513,138.85 on the campaign.

472,866 or 41.3 percent of the county's 1,144,836 voters registered as Democrats and 334,216 voters or 29.2 percent registered as Republicans. Despite those numbers, four of the county's five supervisors are Republicans and on 17 of the county's 24 city and town councils Republicans outnumber Democrats.

A major factor in this

discrepancy between the party affiliation of the county's voters and the political association of the officials elected to represent them consists of the manner in which the Republicans consistently outspend their rival Democrats on political campaigns. The willingness of Postmus and of Dutton to use the power of their political position to not only encourage Republican donors to support their party's standard bearers but to free up money that could be used to make those donations by cutting them breaks on the amount of money they have to pay in tribute to the government has had a direct impact on the outcome of elections, as Republican candidates have consistently been in a position to use the infusion of cash into their political war chests to pay for mailers, hand bills, signs, newspaper ads, radio and televisions spots, telephone banks and other means of promotion to convince voters - in particular the 29.5 percent of voters who are not affiliated with either the Democrats or the Republicans - to vote for Republican candidates.

There is evidence to suggest that Dutton himself was a beneficiary of these arrangements, as no one was willing to oppose him for reelection in 2018 or this year. Armed with the ability to trade lower assessments for a percentage of the money saved in that way being deposited into his

electioneering coffers, Dutton was a formidable opponent to anyone who might challenge him, and no one did.

As early as 2018, Fifth District Supervisor Josie Gonzales, then the lone Democrat on the board of supervisors, conscious that she was due to be termed out of office in 2020, contemplated making a run for assessor, forming in September of that year a committee, Gonzales for Assessor 2022, and began accepting donations into the account for that committee and then transferred into it as well the money she had left over from her previous account for her supervisorial campaigns. By December 31, 2021, she had accumulated into that political war chest nearly half of a million dollars – \$495,147.83.

Still, Gonzales was wary of entering the fray against Dutton, with his ability to tap into a well-spring of donations from donors for whom he was prepared to provide assessment reductions in return for the money he needed to overcome any opponent.

Meanwhile, Dutton was aware that he was facing a far more existential challenge than Gonzales's political one. It is not publicly known precisely when Dutton learned that he had developed prostate cancer, but there are grounds to believe that he had unmistakable signs that he was so afflicted by late 2019. The failure of his doctors to move aggressively against his condition had led to the cancer metastasizing into his bones by 2021 – a virtual death sentence. At that point, it was merely a matter of

Yet Dutton, for whatever reason yet undisclosed, decided to press forward with a re-elective effort in 2022. It is unknown if or how many his medical condition. There were, potentially, practical partisan considerations at play. Had he made a public disclosure of his condition, Gonzales, a Democrat, would see her opening and take it. Her declaration of candidacy and filing to participate in the 2020 election would change the entire dynamic that was in place. Dutton, while he would have access to considerable electioneering funds and held the advantage of incumbency, knew he was a paper political tiger. He understood that he would not have the physical stamina to engage in a campaign, particularly a bruising one that would surely be required if he was faced with an opponent who had half of a million dollars to spend. To preserve the hold the GOP held over the assessor's office and ensure that its taxing authority could continue to be wielded to keep the county Republican machine in control of the entire edifice of San Bernardino County government, the sounder strategy would be to continue to maintain a profile of strength and political invulnerability. That way, he might, as he had done in 2018, stave off any challengers, paving the way for his reelection. In so doing, he would be retained in office without opposition, and remain as assessor as long as his fragile and inevitably deteriorating health held out, at which time he could resign, ensuring that his successor would be chosen by the Republican-controlled board of supervisors.

Whether Dutton had confided in Curt Hagman, the powerful chairman of the board of supervisors, is not known. The *Sentinel* has learned that late last year, Dutton did tell another Republican, a former state legislator, that his cancer had progressed into his skeletal system.

Though the Sentinel late last year and early this year had noted that Dutton was isolated and no longer accessible, and had even picked up a ru-

mor that Dutton was being sequestered by those around him because he was manifesting indications of early-stage dementia, it had no knowledge or inkling of his cancer, let alone its advanced stage.

Equally in the dark, apparently, was Gonzales, who let the March 11 deadline to file to run for assessor elapse. Thus, Dutton faced no opposition in the June 7 primary election. He was reelected with 100 percent of the 200.752 votes cast

200,752 votes cast. No one, not even Dutton, anticipated that his death would come so soon. In the aftermath of his July 23 passing, the board of supervisors failed to act with the alacrity necessary to put the matter of who shall serve as assessor for the term beginning in January 2023 and running through January 2027 before the voters in the upcoming November 8 election.

Instead, the board solicited applications that were due by August 18 from individuals willing to serve in the position of assessor/recorder/county clerk through the expiration of the term that Dutton was elected to in November 2018, running

through January 3, 2023. The board further intends to solicit applications from individuals willing to serve in the position of assessor/recorder/county clerk from January 2023 until January 2025 and to place on the November 2024 ballot a special election to fill the position of assessor/recorder/county clerk from January 2025 until January 2027.

The solicitation brought five responses. One of those was from Dutton's widow, Andrea Dutton, who was married to Dutton for more than 30 years. Josie Gonzales, who did not run in this year's June primary election despite having indicated with the formation of her campaign committee in 2018 that she was interest in the assessor's post, also applied. Another applicant was Larry Walker, an attorney who had been a Chino City Council member and mayor in the 1980s, was elected to the board of supervisors representing the Fourth District from 1986 until 1998, at which point he was elected to the position of county auditorcontroller/recorder/county clerk and served in those combined positions until 2010, whereupon a

reorganization merged the auditor-controller's function with that of the county treasurer/tax collector, a combination of offices Walker was elected to in 2010 and in 2014 and from which he resigned in 2016. Bradley Snowball, a county employee who began with the fiscal division in 1995 and transitioned into an auditor-appraiser position with the assessor's office two years later who now holds a position as a supervisor in the assessor's appeals division, also sought the appointment. Applying as well was Chris Wilhite, who operated the Wilhite Appraisal Service from February 1986 until May of 1990 and the Chris Wilhite Appraisal Service from May of 1990 until July of 2000 and who was hired in July of 2000 to work in the assessor's office, where he steadily advanced until becoming the assistant assessor, described as Dutton's second-in-command.

On September 13, the board of supervisors interviewed the five. The board asked and the candidates fielded questions pertaining to the need for ensuring diversity, equity and inclusion among the *Continued on Page 6*

staff hired into the assessor's, recorder's and county clerk's offices; the relationship between assessor's office and the county's property owners; educating and informing the public as to the function of the three offices; staff retention and recruitment; and what changes should be made in the office.

There were no questions touching on the politicization of the assessor's office's function.

Snowball was interviewed first. He told the board that he had spent a large portion of his career in dealing with appeals.

"I came in at the tail end of the dotcom crash," Snowball said, emphasizing that he had extensive experience assessing properties plagued by hardship. "I worked with the assessor's office in the appeals division post 9-11. We also looked at the economy and the subprime market taking off in the real estate market, which then shifted appeals over to business property. From there we had the worldwide crash from the subprime market. So, basically, for the most part, my career has been spent primarily in appeals. Out of my 25year career with the assessor's office, I have spent at least two-thirds of that in the appeals department."

Snowball indicated he was interested in securing the assessor/recorder/ county clerk appointment until January and continuing to serve in that capacity until 2025 but not running in the November 2024 election.

Gonzales indicated she was interested in getting the three-month appointment until January, the two-year appointment from January 2023 until January 2025 and in seeking election in November 2024 to remain in office until January 2027.

Nevertheless, Gonzales said, she would serve as a caretaker in the position of assessor/recorder/county clerk, and devote herself to whipping the office into shape for whoever might succeed her.

"We know a department the size of the assessor/recorder/clerk's is a bit of a battleship and it's not going to turn on a dime," she said. "There has to be a period in which, if I am appointed, I go out and make the necessary contacts, begin to build a relationship, whether it is that I am appointed on the second term, let alone the first term or not; it's in a sense preparing the ground for whoever will come in for the second term."

With Bob Dutton's death, Gonzales said, the

leadership of the three offices was "wobbly. Working through that and working to realign that ship is going to be a take-a-minute. I want to do that and it's very important for me to set the ground, get it ready for whoever is going to come for what I would say is that latter two years of this appointment process."

Andrea Dutton said she was seeking the appointment to complete the remainder of the term to which her husband was elected in 2018, running until next January, but was not interested is remaining in the post beyond that point.

"If appointed, I will continue with Bob's vision, leadership style, structure and approaches that he was elected to uphold by the voters and his constituents," she said. "He had a strategic plan and I am asking for permission to fulfill it for the last three months of his term. The assessorrecorder's office is one of professionalism, efficiency, integrity, with a commitment to a fair, accurate, equitable and friendly customer service. Given the opportunity, I will continue to lead the 250 employees known as 'Team ARC [assessor, recorder clerk]' with the same leadership style as my husband. I will continue to implement the policies and procedures which are currently practiced by "Team ARC' with the assistance and the collaboration of the existing

staff. This will continue to assure the proper administration of the office of assessor-recorder with the same mission values culture that Bob brought to the county."

Larry Walker, a Democrat, despite initially paying almost fawning tribute to Dutton, during his interview offered the closest delineation, assessment and indictment of the politicization of the assessor's function of any of the candidates.

"Bob Dutton's shoes will be very hard to fill," Walker said in his opening remarks. "He elevated the assessor's position tremendously over the last eight years from what it had been for many years. The challenge will be to sustain what he had built and then seeing if there is a way to improve on that."

In sizing up what he said were his qualifications, Walker said, "I break them down into ability, integrity and experience."

It was in expounding on integrity that Walker made allusion to the manner in which the assessor's function and authority have been used to politically advantage one group over another.

"Integrity actually has two aspects," Walker said. "One is having strength to withstand pressure when necessary. The other is having knowledge of ethical rules, cases and being able to apply them in situations so that the ability to be strong and withstand pressure is coupled

with an ability to identify those areas that deserve that kind of treatment."

Walker said, "As tax collector I had great conversations with people. Nobody's excited about paying their property tax. To me, the question is about service. If you serve the people, then they're not going to be uptight about the fact that you're deciding how much their house is worth, as long as they're convinced that everybody that comes in with that house and those circumstances gets the same assessment. One of the important things about this job is I have to sit here and say my job is to be totally independent of the five of you and make decisions that are according to law and according to my relationship as an elected official with people."

Walker then acknowledged political reality and how the power and partisanship on the board of supervisors is likely to trump principle and ethics. In doing so, he tacitly acknowledged why it was that he would not himself get the appointment.

"Then I have to turn the page and say, 'I want to build a very strong relationship with the board of supervisors' because we have to work together to make this system work for the people of San Bernardino County," he said.

During his interview, Wilhite evinced a command of the ins and outs of the assessor's office as it is currently being run. In summarizing how the department should be managed, he said, "We want to be open and fair to the property owners and the taxpayers... to provide them an answer without being bureaucratic."

During his questioning of Wilhite, Chairman of the Board Curt Hagman telegraphed that Wilhite's selection was a foregone conclusion.

"From your position as assistant, what are some of the things we need to be doing better to prepare for the future?" Hagman asked. "I know on several applications, you all predicted [a] downturn in the real estate market. So, obviously us (sic) as

a county have to look at our budgets coming forward, but also potential split roll and other things. What are some of the things that may keep you up at night that we need to be addressing today?"

In answering the question, Wilhite referenced numerous ongoing circumstances in the office he has been dealing with in the more than monthand-a-half since Dutton's death while serving as the office's de facto leader as if he was practically being set up to continue in just such a position, such that he was the logical heir apparent to Dutton.

Second District Supervisor Janice Rutherford said, "While I think we have many qualified candidates and you would each bring something very unique to the office, it struck me that Mr. Wilhite having been put in that position by Bob and by evidence of his detailed knowledge on the interview and the PMIS [project information management system] project and a variety of other tasks going on in the office, is the best person to get us through the interim, provide the most stability to the organization, continue to lead the staff that he has already been helpful in leading. And he demonstrated to me through his application and his comments here today that he would be the best of this great group of applicants.

After First District Supervisor Paul Cook, Fifth District Supervisor Joe Baca Jr and Third District Supervisor Dawn Rowe indicated they were likewise favorably impressed by Wilhite, Hagman said, "I think the consensus is to keep the trains going for the next three months and get through some of these milestones that the department has to go through."

Baca made a motion to appoint Wilhite, seconded by Rutherford, which was unanimously passed.

Though the board is intent on following up this month's appointment of Wilhite with a second solicitation of applications, likely in November, followed by action *Continued on Page 12*

recovery operation and positively identified the deceased as Doris Jagiello.

According to the sheriff's department, "As a large debris flow consisting of mud and extremely large boulders raced downhill, it overran Jagiello's property and impacted her home, causing significant structural damage and carrying away everything in its path." A public safety exclu-

sion area remains in place for Prospect Road and Canyon Road in Forest Falls to allow work crews to safely remove the remaining debris and large boulders blocking the roads. In Yucaipa, Casa Blanca was closed at Oak Glen Road as mudslides created hazards.

In Oak Glen, mudslides resulted in damage to a number of homes, and passage on Oak Glen Road was terminated by an order of the fire department at Little San Gorgonio Creek.

On Highway 38 further up in the San Ber-

nardino Mountains, the road was barricaded between Bryant Street and Lake Williams Drive because the area was subject to mudslides and dislodge boulders.

At a specially-called meeting on Thursday, September 15, the San Bernardino County Board of Supervisors unanimously approved declaring a state of emergency, which will allow the county to access state and federal emergency aid funding.

The proclamation of the local emergency approved by the supervisors states that the Hurricane Kay tem produced up to 2.4 inches of rain within one hour over the El Dorado/ Apple Fire Burn Scar and subsequent intermittent thunderstorms continued through September 13, 2022 at approximately 2200 hours, resulting in a need for emergency protective measures, evacuation orders, shelter in place orders, emergency repairs/detours, and [an] ongoing search and rescue operation of areas impacted by debris flow."

Despite that, and the consideration that he outspent all six of his opponents in the contest, Valdivia finished third, with 2,970 votes or 16.92 percent, behind second-place finisher Jim Penman, who polled 3,510 votes or 20 percent, and the top vote-getter, Helen Tran, with 7,310 votes or 41.65 percent. Thus, Valdivia did not qualify for the runoff.

A one-time Valdivia associate/political porter shortly after the election observed that if Valdivia had used the money provided to him by his donors as they intended it for electioneering purposes rather than diverting it to defray his legal bills, he would have been reelected.

As of June 30, Valdivia's election fund had an ending cash balance of \$43,988.38 and equivalents of \$222,695.24. Immediately after the election, Valdivia departed for the East Coast, where, it was said, he was to fly to Europe. There was concern that he was engaged in an tial portion of his remaining electioneering funds into banking institutions in New York and potentially Switzerland, allowing him eventually to take control of that money and convert it to his own personal use. As it turned out, Valdivia did not make a sojourn to Europe as it was reported he had previously intended. According to the mid-

The county in the face of such a challenge would no doubt assert that given the timing of Dutton's death and the expense of conducting a stand-alone countywide election, the county is acting in a fiscally responsible manner by making the two-year

in December to appoint someone to serve as assessor/recorder/county clerk from January 2023 to 2025, there are legal experts who maintain that action will not pass constitutional and California Government Code and California Elections Code muster if it is challenged, as it does not appear that the board of supervisors has the authority to appoint Dutton's successor for the timeframe between January 2023 and January 2025 as it is purposed to do in December.

The board is within its discretionary power to appoint a replacement/

successor for someone in a constitutional position who has vacated that position during an ongoing term, either by removal, resignation or, as in this case, death. The board's authority to replace an absent duly-elected official does not, under the governmental code and election code, translate into the power to bypass the citizenry it represents and use that power of replacement to substitute an appointment for an election. An important consideration is that in January 2019 Dutton was sworn in to serve as assessor from January 2019 to January 2023,
