

Aguilar Now The 3rd Most Powerful Democrat In The House Of Representatives

Congressman Pete Aguilar this week continued his meteoric political rise, achieving what is widely considered to be the third highest-ranking position among Democrats in the House of Representatives.

For Aguilar, the accomplishment was welcome but somewhat bittersweet, as it comes within two weeks after late returns in a handful of close congressional races confirm that

Republicans will hold a majority of the House seats during the 118th Congress that is to convene on January 3, 2023 and last until January 3, 2025, a change from the current 117th Congress, wherein the Democrats had a House majority.

On Wednesday, November 30, House Democrats selected Aguilar as House Democratic Caucus chairman. His advancement was part of a complete makeover of

the Democratic leadership in the House, as he is replacing Steny Hoyer of Maryland, who was the majority leader during the 117th Congress; Representative Hakeem Jeffries of New York is to replace Nancy Pelosi, who was Speaker of the House, as the Democratic Party leader; and Congresswoman Katherine Clark of Massachusetts is to replace James Clyburn of South Carolina as Democratic Whip on

January 3. In a prepared statement, Aguilar said, "I'm grateful to my colleagues for the faith they've placed in me and for the opportunity to continue our work putting people over politics. As we honor the legacies of Nancy Pelosi and Steny Hoyer, and prepare for a new generation of leadership, our caucus is more united than ever. I look forward to bringing together all the voices in our party to safe-

guard the progress we've made."

He took the opportunity to needle his Republican rivals — who on January 3 will constitute a majority of the members of the House of Representatives — as "extremists."

Aguilar said, "House Democrats are committed to a legislative agenda that lowers costs, protects abortion rights, strengthens Democracy, and tackles

Congresswoman's Office Asserts She Was "Hoodwinked" Into Getting Fontana Federal Grant

Congresswoman Norma Torres was hoodwinked into arranging a federal clean energy grant for the City of Fontana that elected city officials there intend to use to defray the partial cost of a no-bid energy efficientization contract intended as a payoff to an entity who has committed to bankroll their political campaigns and

retire their electioneering debts, Torres' staff has acknowledged.

Torres did not know, the *Sentinel* was assured, about Fontana's previous history in opting out of the open bidding process so that contracts for three clean energy projects were given to a developer favored by the city council majority. Torres, the member of the House of Repre-

sentatives in California's 35th Congressional District, on November 22 announced that six of the cities that fall within her Inland Empire district and both Los Angeles and San Bernardino counties were being allocated \$2.75 million in clean energy grants. The funding is being provided through the Department of Energy's Energy Efficiency and Conser-

vation Block Grant Program, which supports the development of clean energy projects across the nation to cut pollution, lower energy costs for families, and help reach a federal goal of the United States cutting greenhouse gas emissions in half by 2030. As a consequence of the Bipartisan Infrastructure Law, which Torres championed, a total of

\$550 million in Energy Efficiency and Conservation Block Grant grants is being distributed nationwide.

"The Bipartisan Infrastructure Law is supercharging America's clean energy future, and with these latest investments, we're delivering on our commitment to lower costs, cut pollution, and build a healthier future for

After Five Years Of Marijuana Experimentation, Hesperia Rescinding Limited Drug Sales Program

Hesperia has become the first city in San Bernardino County to rescind permission the city previously granted to entrepreneurs to sell marijuana within its jurisdiction.

While 17 of San Bernardino County's 24 municipalities have never considered allowing marijuana to be sold within their borders, six

- Needles, Adelanto, San Bernardino, Hesperia, Barstow & Fontana, approved doing so. One, Colton, has a tax scheme in place if the drug is sold there, but permission to make such sales has never been granted.

That Hesperia has receded from the liberalization it once embraced is not surprising. From the outset, Hesper-

ria's willingness to venture into the province of permitting commercial marijuana sales appeared unlikely.

In 2012, cash strapped Needles and in 2015 foundering Adelanto, followed by bankrupt San Bernardino in 2016 moved to allow what was at first medical marijuana sales to take place in their cities.

Commercial Passenger Flights To Begin Next Week Out of SB International Airport

An Upland woman was found dead in the remote desert area of northeast San Bernardino County not too distant from the Nevada California border on November 26 after a bizarre set of events that and the previous day.

Circumstances suggest the woman, 31-year-old Sonia Flores, was beaten to death by her husband, 37-year-old

Jesus Jaimes-Rosas, the day before she was found.

Authorities have been guided in their thus-far determination of what apparently occurred by an account provided by the couple's 12-year-old daughter who witnessed her father's fatal assault and abandonment of her mother.

On Friday, November 25, 2022, at about 11:45

p.m., deputies from the Barstow Sheriff's Station responded to the Shell Gas Station on Cima Road following a report that a 12-year-old female child walked into the station's retail store and requested help.

A California Highway Patrol Officer was the first authority to arrive at the location. Later, when sheriff's deputies arrived, the child related

that her father had beaten her mother and left her on the side of the road.

The child's father was later identified as Jesus Jaimes-Rosas, who had dropped the child off at the gas station and left.

Less than two hours later, on Saturday, November 26, 2022 at about 1:23 a.m., deputies located Jaimes-Rosas' abandoned vehicle on a dirt road. A Sheriff's

K9 Unit was dispatched to the scene and located Jaimes-Rosas with self-inflicted injuries. He was transported to a hospital and later released.

At 11:43 a.m. on November 26, Sonia Flores, the girl's deceased mother, was located by authorities near Powerline and Kingston roads in Mountain Pass. The Sheriff's Specialized Investigations Di-

Armendarez Starting With 4 Experienced Figures As He Fleshes Out Second District Supervisorial Office Team

Less than a month after Jesse Armendarez's November 8 electoral victory over Luis Cetina in the race to fill the Second District supervisorial position for the coming four years, a few details have emerged about how he will staff his office.

Of major note is that reports are Fontana Mayor Acquanetta Warren is to have a prominent staff position in the Second District once Armendarez is sworn into office in January.

In addition, Neil Derry, who served as Third District supervisor for four years until he left office a decade ago, is to come in and guide, for six months or thereabouts, Armendarez's assumption of the Second District reins from outgoing Supervisor Janice Rutherford.

Armendarez appears determined, at least initially, to rely upon old hands in taking on the supervisor's role, ones who have considerable governmental experience, notably in elected roles.

Moreover, beyond the higher profile show horses of Warren and Derry, he has reached out to two work horses with experience within governmental operations. Cindy Dalton, who has extensive nuts and bolts experience with the rudimentary of governmental paperwork and documentation, is one of those and Naseem Farooqi, a journeyman middle managerial functionary within

gun violence. While the American people want both parties in Congress to work together, we are prepared to fight back against Republican extremism and their plans to cut Social Security and Medicare, to give tax breaks to wealthy corporations that ship jobs overseas and to enact a national abortion ban.”

The Democratic Caucus consists of all Democrats in the House. Aguilar’s assignment as caucus chairman will be to preside over weekly caucus meetings, where party policy and legislative strategy is discussed. The chairman is elected by the caucus and limited to two consecutive full terms.

Earlier this month, as the outcome of the November 8 election was being firmed up, Pelosi, who led the Democratic party in Congress for more than 20 years as the first woman to serve as Speaker of the House, announced she would step down as House Democratic leader at the end of the year. Jeffries, who is to succeed her, is the first African American to lead a major political party in Congress.

Though he has enjoyed a string of 12 electoral victories against a single loss over a decade-and-a-half, with seven of those victories in general elections and five in primaries, Aguilar did not begin his public office career through the electoral process but rather was boosted by two crucial appointments to posts very early on. In 2001, just after graduating from Redlands University, Aguilar was appointed by then-California Governor Gray Davis to serve as the deputy director of Davis’s Inland Empire regional office. He acceded to the position of interim director just before suffering the setback

of Davis’s 2003 recall from office. Having once been escorted into the inner sanctum of governance without having to face the voters, Aguilar in 2006 again wangled a key appointment, this time to the Redlands City Council as one of 11 applicants competing for the post, in the aftermath of Susan Peppler’s resignation from that panel.

In 2007, Aguilar was elected to the council in his own right and was twice rotated into the ceremonial position of mayor by his council colleagues. He was benefited with a one-year extension in office when Redlands moved to even-year elections, such that he did not need to compete to remain on the council in 2011, as was previously scheduled, with his term lasting instead to 2012. That year, he competed against three other Democrats and two Republicans for Congress in California’s 31st Congressional District. That would prove his only loss to date, with both of the Republicans – incumbent Congressman Gary Miller and State Senator Bob Dutton – beating him in the primary and ending his Congressional hopes for that year. Having stumbled, Aguilar did not fall, as he ran for reelection to the city council that November, and was handily reelected.

In 2014, when Miller opted out of seeking reelection, Aguilar again ran for Congress in the 31st, and was joined in that effort by three Democrats – Eloise Gomez-Reyes, Joe Baca Sr and Danny Tillman, two bona fide Republicans – Leslie Gooch and Paul Chabot – along with a Democratic plant masquerading as a Republican, Ryan Downing. As Gooch and Chabot were the best-financed of the seven candidates, expectations were that both would monopolize the Republican vote and capture a significant percentage of the unaffiliated voters and those members of the more marginal political parties, so that the Democrats would be shut out of the general

election, which would feature Gooch and Chabot going head-to-head. Chabot, concerned about Gooch’s status as the policy director on Miller’s congressional staff and the endorsements she was picking up from the Republican Party mainstream, ran a primary campaign that ignored all of his Democratic competition and featured attack ads against Gooch. This garnered him first place in the voting and hurt Gooch, who slipped into third place behind the second-place finisher, Aguilar. Thus, Aguilar found himself in the November general election in a district with a slight but less than overwhelming Democratic voter registration advantage. Chabot, having

successfully captured first place and a berth in the final go-round, had nonetheless, by his savaging of Gooch, offended and antagonized the Republican donors he would need to prevail in that November election. Ultimately, without a sufficiently funded campaign in November 2014, Chabot fell short, with 48,162 or 48.3 percent of the 99,784 votes cast, while Aguilar eked out an unlikely and narrow victory, with 51,622 votes or 51.7 percent. The fashion in which he cut his sister Republican, Gooch, off at the pass to advance to the general election against a Democrat and then failed to capitalize on that strategy essentially brought an end to Chabot’s political viability.

That was demonstrated two years later when Aguilar and Chabot found themselves up against one another in the 2016 primary, which also featured Republican Sean Flynn, Democrat-turned Republican Joe Baca Sr and Democrat

Kaisar Ahmed. Aguilar and Chabot finished first and second, respectively, to make it to the November 2016 General Election, in which Aguilar again vanguarded Chabot, more convincingly that time around, with 121,070 or 56.1 percent of the 215,936 votes cast to Chabot’s 94,866 or 43.9 percent.

In 2018, the primary field in the 31st District had shrunk to Aguilar, Flynn and Ahmed. In the November 2018 General Election, Aguilar hammered Flynn, 110,143 votes or 58.7 percent to 77,352 or 41.3 percent.

In 2020, Aguilar was challenged by a single alternative candidate, Republican Agnes Gibboney, on both the primary and general ballots. He cruised to an easy 175,315 vote or 61.3 percent victory in November over Gibboney, who polled 110,735 votes or 38.7 percent.

This year, Aguilar vanquished three Republicans – John Mark Porter, Rex Gutierrez and Ernest Richter – in California’s open June 7 Primary and then defeated Porter 30,949 or 57.7 percent to 22,695 or 42.3 percent on November 8.

Over the last two years, the Democratic Party has done much to promote Aguilar. This included Speaker Pelosi appointing him as one of eight House members to the U.S. House Select Committee to Investigate the January 6th [2021] Attack on the United States Capital. On June 16, 2022, which came nine days after the California Primary, Aguilar along with John Wood, a lawyer for the select committee, led the committee’s third televised hearing, focusing on then-President Donald Trump’s efforts to pressure then-Vice President Mike Pence into decertifying the 2020 presidential election.

The *Sentinel* spoke with a former Republican legislator who represented San Bernardino County and served multiple terms in office before returning to the private sector. The legislator asked to not be quoted by name because

she/he did not want to be perceived as being on speaking terms with the *Sentinel*.

The former legislator put little stock in the observation that Aguilar’s advancement to a position of influence in the Democratic Party has come only after the Democrats lost the majority position in the House.

“What you are seeing is the progression of time and the retirement of the Old Guard,” the former legislator said. “The New Guard is stepping up.”

Moreover, the former legislator said of Aguilar, “He was taking on more and more of a leadership role under Pelosi the last few years.”

It was true, the legislator said, that Aguilar had not been perceived as a political heavyweight previously, and that the general impression was that he had moved ahead largely on the basis of the general rise of Latino officeholders over the last two decades. Nevertheless, the legislator said, it was a reality that Aguilar is now quite

powerful.

“It is hard to argue with results,” he/she said. “It has been a long time since the Inland Empire had someone as highly placed as this. It is not a bad thing that we have someone with that much pull in Congress. Of course, we [i.e., local Republicans] would rather that it be a Republican.”

There is no mistaking that Aguilar is a Democrat, first and foremost, the legislator said, but he is less strident in his partisanship than many other Democrats, the former legislator said. That is partially because early and midway in his career, Aguilar was assisted by Republicans, she/he said.

“It was a Republican [city] council, or more of a Republican council than a Democratic one, that appointed him to the city council before he was ever elected,” the legislator said. “Pat Gilbreth supported him. Before he went to Congress, he wasn’t what you would think of as a hardcore Democrat.”

Problems had ensued in all three cases, primarily Adelanto, where then Mayor Rich Kerr and then-Councilman Jermaine right were hip-deep in bribe money being passed along to them by would-be marijuana entrepreneurs who were lining up at the city’s

planning division counter carrying briefcases full of cash. Ultimately, the FBI and the U.S. Attorney’s office caught up with Kerr and Wright.

In San Bernardino, Mayor John Valdivia used his consulting company, Aadvantage Communications LLC, to take money from applicants for the city’s marijuana/cannabis-related commercial permits,

people in the Inland Empire,” Torres said with enthusiasm at the time. “With the Energy Efficiency and Conservation Block Grant Program, local governments as well as tribal communities in California are now one step closer to reaching their clean energy and energy efficiency goals, and I look forward to working with local officials to deliver on these game-changing projects.”

Previously in Fontana, Mayor Acquanetta Warren and her ruling coalition on the council have steered three energy efficiency project contracts worth a combined \$9.4 million to Alliance Building Solutions, using a loophole in California law that suspends the requirement that public agencies and governmental entities use an open bidding process on

contracts for capital projects if the project pertains either to increasing energy efficiency or can be demonstrated to have saved the agency/governmental entity on energy costs. According to those within Fontana’s governmental structure, Mayor Warren and her allies on the council deliberately used this loophole so that Alliance Building Solutions could be awarded the contracts in question despite the consideration that there were other companies offering the same energy efficiency upgrades at a lower cost than Alliance Building Solutions.

This bypassing of the open bidding requirement was choreographed, the *Sentinel* was told, by former San Bernardino County Supervisor Bill Postmus, who has reinvented himself as a lobbyist and political fixer and is acting as what was variously described as a “cut-out” or “go-between” to convey money from Alliance Building Solutions principal Brad Chapman to Mayor Warren and the other decision-makers on the Fontana City Council, money intended to

“grease” the mayor and council and thus facilitate the provision of the no-bid contract to Alliance Building Solutions. In essence, the *Sentinel* is told, the monetary installments originating with Chapman being delivered to the mayor and council members through the laundering process involving Postmus are quid pro quos, bribes paid in return for the approval of the energy efficientization projects.

Because of Torres’ intercession, Fontana was given the largest portion of the money reserved for the 35th District’s cities. The City of Pomona was provided with \$188,070; the City of Fontana, \$230,640; the City of Montclair, \$76,320; the City of Chino, \$147,470; the City of Ontario: \$218,330; the City of Rialto, \$151,580. San Bernardino County received \$393,590 and Los Angeles County was given \$1,344,700.

Elements within Fontana City Hall have informed the *Sentinel* that Warren and the council intend to utilize the Energy Efficiency and Conservation Block Grant

Program in combination with other money available to the city to enter into another no-bid contract with Alliance Building Solutions.

Congresswoman Torres did not learn of Fontana officials’ plans for the questionable routing of federal money she had obtained for the city to Alliance Building Solutions until this week, members of her office said. In the immediate aftermath of learning what was in the offing, she was unwilling to make any public statement, while her staff sought to formulate some sort of official reaction. Her staff balked at saying anything whatsoever, beyond insisting the Congresswoman had no previous understanding of how Fontana was planning to use the funds. In this way, the *Sentinel* was told, publicity that implied she had been duped or hoodwinked, while not of the sort the Congresswoman wants to have her constituents read about in the press, was preferable to coverage that implies she knew what purpose Fontana would put the money to or that she was

aware of the previous arrangements by which Alliance Building Solutions were awarded no-bid contracts.

Torres’ office spokesman, Justin Krakoff, accepted questions this week as to whether there was any requirement put into the grant award that the contracts to be paid for by the grant must be ones that use an open-bid process and, if there was no requirement put into the grant award that the contracts to be paid for by the grant must be ones that use an open-bid process, that upon scrutiny of the situation, the Congresswoman is now intent to add a condition to the award by which any contracts to be paid for by the grant must be ones

Krakoff did not respond by press time.

Fontana City Manager Matt Ballantyne told the *Sentinel* that he was not on top of what was going on with Fontana’s reception of the Energy Efficiency and Conservation Block Grant Program grant, an indication the matter was being handled between a lower level staff member and the city council.

“I am not familiar with the energy block grant you are referring to,” Ballantyne said. “I have not met or spoke to Bill Postmus or Brad Chapman. I do support seeking multiple proposals/bids.”

Rafferty forced the city into district elections, a ploy he said would ensure minority representation on the Victorville City Council.

local government, including at the county, is the other that has been identified thus far.

So, while it appears that Armendarez will move on from the staff that Rutherford employed during her 12 years in county office, he so far has not committed to hiring anyone who does not have extensive experience or a proven track record in local governmental operations.

“I’ve been in close contact with the county administrative office,” Armendarez said. “We will have a well-experienced staff to immediately begin working to bring proven solutions towards the issues impacting our communities.”

Armendarez’s intended hiring of War-

ren in January is by no means surprising and is understandable on multiple levels. Warren can be considered Armendarez’s political mentor. Quite possibly, he would not have arrived at his current position without her intercession some eight years ago, followed by another key boost six years ago.

A real estate professional both based and living in Fontana and a successful one at that, Armendarez more than a decade ago demonstrated a willingness to put up his own money in backing local political candidates. As a businessman in Fontana, that meant Armendarez gravitated toward Warren, who had been in office since 2002, when she was appointed to replace Mark Nuami on the city council when he had been elected mayor midway in his second term on the council. In 2004, Warren was elected to the council in her

own right and reelected in 2008. In 2010, she successfully vied for mayor and would go on to be reelected in 2014, 2018 and again last month. Warren, who is San Bernardino County’s most prominent African American Republican officeholder, has long advocated the sort of aggressive economic development policies that Armendarez as a real estate professional espouses. He early on was counted among Warren’s many generous donors.

Warren’s political reach extends virtually everywhere in Fontana, including the school board. In 2014, there was a perfect marriage between her desire to control or at least maintain a degree of influence over that panel and Armendarez’s growing political interest. She supported him in a run for the school board. Her guidance and support and Armendarez’s willingness to utilize his own

personal wealth to fuel his campaign proved a winning combination.

In 2016, Warren’s determination to prevent her two rivals on the city council, Councilman Jesse Sandoval and Councilwoman Lydia Salazar-Wibert, from

establishing an effective bulwark against her domination of the council created once more an opportunity for Armendarez to advance. Again with Warren’s guidance and the application his own money, Armendarez launched himself another couple of rungs up the political ladder by defeating Salazar-Wibert in that year’s

city council election. For the next four years, Armendarez was a solid member of the ruling coalition on the Fontana City Council Warren controlled.

In 2020, Armendarez reached for the brass ring when he ran for Fifth District Supervisor, but it eluded his grasp. He finished in second place in the March 2020 primary, qualifying for the run-off against then-Rialto City Councilman Joe Baca Jr in the November election. Thus, Armendarez was not able to run for reelection to the Fontana City Council in November 2020, as he was engaged in a political slugfest with Baca. Ultimately, Baca, a Democrat, prevailed in that contest, as Democrats outnumber Republicans nearly 5-to-2 in the Fifth Supervisorial District, which at that time stretched from mid-San Bernardino in the east through all of Muscoy, all of Colton,

all of Bloomington, all of Rialto and more than a third of Fontana in the west.

In 2021, however, the county’s electoral map was redrawn in correspondence to the 2020 Census, and all of Fontana, including Armendarez’s neighborhood, was placed into the Second Supervisorial District. This gave Armendarez a rare opportunity to run for the board of supervisors twice in two years. He did so, placing second among five candidates in the June primary and then engaging in a hard-fought campaign against Luis Cetina in the fall campaign. Though Cetina had bettered Armendarez by roughly three percentage points in June, Armendarez outthrustled and outlasted him in November, prevailing with 48,025 votes or 53.63 percent to Cetina’s 41,516 or 46.37 percent.

promising approval of their applications in return.

In Hesperia both residents and elected officials were philosophical out of tune with those advocating for marijuana availability. Nevertheless, there evolved two-prime movers in dismantling that barrier: Bill Postmus and James Previti Jr.

Postmus, who had been elected San Bernardino County First District supervisor in 2000, later served as San Bernardino County Republican Central Committee Chairman, was reelected to the board of supervisors in 2004 and was elected San Bernardino County assessor in 2006. Having begun as a no-nonsense conservative, Christian values right-leaning politician who excoriated “potheads” as criminals whose right to vote should be rescinded, Postmus obtained his initial groundswell of support from the Republican Party and its most strident ideologues. He soared to virtually immeasurable heights as the political leader of San Bernardino County and the local GOP machine that dominated it in the first decade of the Third Millennium. But as the chairman of the San Bernardino County Board of Supervisors, on one occasion and then again and again, he had smoked a little pot himself and learned that it really wasn’t that bad. It encouraged his intellectual curiosity, Postmus discovered. Along the way he tried methamphetamine, and he soon developed an affinity for it, as it gave him intensity and renewed energy, he came to see. While he was yet the chairman of the board of supervisors, he thought nothing of smoking it or using a syringe to inject it. Shortly thereafter, things went bad for him and he was forced to resign from office, charged with a misdemeanor drug offense relating to

some methamphetamine found in his home as well as 14 felony political corruption and public office violations, including conspiracy, bribery, solicitation of a bribe, acceptance of a bribe, fraud, conflict of interest by a public official, misappropriation of public funds, fraud and perjury. He was convicted on all 15 charges, barred from holding elected public office in California and sent to prison.

Postmus nevertheless sought to remain in the political game, sojourning to Wyoming, where he founded a company, Mountain States Consulting Group, which he employs in California as a political consulting and political donation laundering vehicle. Having utilized the public offices of supervisor and assessor he once held to engage in influence peddling and been caught, Postmus now assists San Bernardino County’s current crop of politicians/officeholders in receiving money and support from people who have a stake in governmental decision-making and who want to be able to take action to assist their political patrons without the public, the press, other politicians or prosecutors fully grasping what is taking place. In this way, Bill Postmus and Mountain States Consulting Group keep the politicians he is a consultant to from being charged and convicted like he was.

In addition, Postmus, with his business partner, John “Dino” DeFazio, has an interest in a marijuana cultivation operation in Needles. Money generated from that operation is used to promote politicians who are willing to support a host of marijuana/cannabis-related business applicants who have retained Mountain States Consulting Group to help them get licensing and permits to operate in various locales in San Bernardino County, including Needles, Ad-

elanto, San Bernardino and Hesperia.

Postmus and Mountain States Consulting Group were instrumental in promoting the Hesperia City Council candidacies of Paul Russ, a longtime Postmus political affiliate, in 2014, and Rebekah Swanson, the wife of another longtime Postmus political associate, Hesperia School Board Member Eric Swanson, in 2016. To assist Postmus in promoting both Russ and Swanson, Mountain States Consulting Group hired Jeremiah Brosowske as a secondary operative.

In 2012, Russ Blewett, who had been elected to the Hesperia City Council in 2010, ran for First District County supervisor. In 2016, Paul Russ, who had been on the Hesperia City Council since 2014, and Bill Holland, who had been on the Hesperia City Council since 2010, both ran for First District San Bernardino County supervisor. Neither Blewett nor Russ nor Holland proved successful in their ambition to become supervisor. All three, however, had been heavily supported in their various electoral efforts, both for the council and the board of supervisors, by developer James Previti, Jr, whose emphasis was on residential subdivisions through his company, Frontier Homes.

On November 7, 2016, Previti, a residential developer active in Adelanto, Hesperia and Rancho Cucamonga among other places, registered Industrial Integrity Solutions as one of the corporate subsidiaries of his company, Frontier Enterprises. On November 16, Industrial Integrity Solutions purchased 31 acres in Adelanto at 12011 Air Expressway. Thirteen days after the purchase, on November 29, 2016, the Adelanto planning commission rezoned the district around that span of Air Expressway so that marijuana cultivation could take place there. In record time, Previti was given clearance to proceed with the project, and groundbreaking took place in February, 2017. Once

more in record time, Previti’s 30-acre industrial park on those 31 acres was completed and divided into 21 units, each of which was marketed to marijuana cultivators for \$7.5 million each. Previti had made an out-an-out killing, all under the watchful and approving eyes of Mayor Rich Kerr and Councilman Jermaine Wright. In September 2017, the Hesperia City Council, the majority of which was at that point under the sway of both Postmus and Previti, passed an ordinance which, while yet banning storefront retail sales and the outdoor growing of marijuana, created a regulation regime for the home delivery of marijuana and the basing of such operations within the city, along with, pursuant to regulations, the indoor cultivation of the weed. The following year, the city put into place the regime for allowing home marijuana delivery operations, essentially dispensing, for the time being, with allowing indoor nurseries to be licensed in the city.

There were a few things about that development that did not scan. Just three months before, Blewett, a dedicated Mormon, had vowed that marijuana would never be sold in his city. City officials were still committed to portraying Hesperia as a “City of Progress” that adhered to “Fundamentally Conservative Values.” Blewett was suddenly being quoted to the effect that “compassion” dictated medical marijuana be available to “those who need it.” In actuality, it was Previti’s money and the chance that a 30-acre industrial park would soon be constructed in Hesperia that represented something which couldn’t be argued with.

In May 2018, Blewett, who was then Hesperia’s appointed mayor, died. The four surviving members of the council huddled, elevated Holland to serve as mayor and invited applications from those residents of the city interested in replacing Blewett on the council. When the council

interviewed those applicants, it did so in a forum so that the interviewees did not know the questions. Holland, however, conducted the proceedings in such a way that the applicant the majority wanted – Brosowske, whose actual residence in the city was somewhat dubitable – was briefed on the questions before he was brought in as the final applicant to be considered. Only Councilman Larry Bird opposed Brosowske’s Holland, Russ and Swanson voted to appoint Brosowske.

Brosowske’s immediate focus, other than ensuring that he would be elected in the November 2018 city council race, the first by-district contest in the city’s then-30-year history, was to move the city toward the next phase of marijuana legalization. His intent was to clear the way and make it inevitable that Hesperia would over the next two years legalize storefront sales of marijuana, both for medical and recreational purposes, and that the city permit large-scale cultivation facilities such as the ones by which Previti and Postmus/DeFazio were profiting in Adelanto and Needles.

That eventuality was thwarted by two developments, however. First, though Brosowske and Holland prevailed in the November 2018 election, Russ did not, having been displaced by Cameron Gregg. Second, during the 2018 campaign, Holland, who until that point had been in Previti’s pocket based upon the previous investments Previti had made in Holland’s political career, grew suddenly self-conscious about being seen as reflexively supporting everything that Previti wanted. In particular, Previti had been seeking in 2018 a commitment from the city that it would cover the cost of constructing streets and roads into a residential subdivision Previti was pursuing in the south part of the city. Holland, until the election season passed, wanted to hold off on making that commitment, lest his opponents use such

a vote to point out the degree to which he was a Previti lapdog. While thus temporizing, Holland sought to feign independence from Previti by publicly remarking that since Previti was to profit so handsomely by building in Hesperia, he could pay for his own infrastructure. When a report of what Holland had said made its way back to Previti, the developer instead of recognizing it as the campaign rhetoric it was and exercising patience and allowing the campaign season to pass, after which time Holland would be free to vote to support having the city defray the cost of the infrastructure, sought to force the issue. Previti’s team insisted that it was only right that the City of Hesperia construct the access roads to the project Frontier Homes was building. This required Holland to double down and insist that Frontier Homes construct and pay for the roads in question. This created a contretemps that outlasted the campaign.

Within a month and a half of the election, Previti was bankrolling a recall effort targeting Holland, one in which Brosowske took an ill-advised high profile role. Ultimately, the effort to recall Holland came to naught, but not before it created indelible bad blood between, on one hand, Holland, and on the other, Previti, Brosowske and Swanson.

Thereafter, whatever prospect of intensifying the commercial cannabis activity in Hesperia that once existed was dashed, indeed shattered entirely, when over the summer of 2019 questions about Brosowske’s actual residency, including whether he was living at the apartment he was renting in Hesperia’s District 4, emerged. This culminated in the September 2019 removal of Brosowske from the city council, which was supported by Holland, Bird and Gregg and opposed by Brosowske and Swanson. The following month, the council appointed Brigit Bennington, whom Holland and

Aside from the political connection between Armendarez and Warren, the institutional knowledge that Warren brings to the table will be of value to the Second District, Armendarez believes. Warren, in addition to leading Fontana since 2010 and being on the council since 2002, has lived in Fontana since 1992, a year after she went to work in the City of Upland. Warren was an employee in the City of Gracious Living for 25 years, retiring as the assistant public works director there in 2016.

There is precedent for a member of the board of supervisors employing a former city council colleague as a member of his staff. Such was the case when Fourth District Supervisor Curt Hagman hired Ed Graham as a field representative and a policy advisor. Hagman and Graham were members of the Chino Hills City Council in the early 2000s, prior to Hagman's election to the California Assembly, which he left in 2014 upon being termed out, whereupon he

successfully vied for the board of supervisors.

Derry was a member of the San Bernardino City Council when he successfully vied for Third District supervisor in 2008, defeating incumbent Supervisor Dennis Hansberger. He remained

on the board of supervisors for one term, and was displaced by James Ramos in the 2012 election.

the council had overlooked when she applied to replace Blewett in the summer of 2018 and who narrowly lost to Brosowske in the November 18 election, as his replacement.

For many in Hesperia, which is home to two large congregations of both conservative Baptists and Pentecostal faithful who were key Postmus backers before he made his slide into drug use more than a decade and a half ago, marijuana is a plant with its roots in hell. The religious and politically conservative in Hesperia who take their philosophies seriously are dead set against allowing the drug to be commercially available in the city. They reject the argument – one made by Brosowske and Postmus – that marijuana is the wave of the future and that conservative Republicans should not abandon the field of lucrative marijuana sales to the Democrats who use the revenue from it to fund their liberal candidates, liberal causes and the perpetuation of their liberal lifestyle. Rather, Brosowske and Postmus have insisted that political conservatives should instead seek to monopolize the commercialization of the drug for themselves to use the millions of dollars in revenue its sale will provide to promote conservative candidates, causes and Republicans.

Hesperia Councilman Larry Bird, like everyone on the Hesperia City Council, is a Republican. Bird is the principal at Sultana High School in Hesperia.

Marijuana availability advocates assert that the marijuana/cannabis-based product delivery system that exists in Hesperia allows those who need medical marijuana to maintain the quality of their lives get the medicine they are en-

titled to under California law. Bird points out that the availability of medical marijuana to Hesperia residents from delivery companies based in the city has been, in some cases, abused by those who do not actually use the marijuana they obtain in that way as medicine but rather for its intoxicative effect. As the principal at Sultana High, Bird is aware of times where the marijuana that originated with the city's licensed and permitted marijuana distributors ended up in the hands of high school students, who oxidized it by fire and inhaled it into their lungs. Those students were not using marijuana as medicine, Bird insists. They were imbibing to get high.

Members of the council and high ranking staff members at Hesperia City Hall are aware of what are considered irregularities involving the city's permitted marijuana/cannabis-related product delivery businesses.

A handful of the owners of those businesses were involved in the effort to recall Holland. The presence of the marijuana distribution businesses have emboldened at least two of the smoke shop operators in Hesperia to clandestinely sell marijuana out of their storefronts despite cannabis sales being prohibited there. Furthermore, an incident from roughly three years ago soured city officials with regard to the presence of cannabis-related delivery establishments in Hesperia. City Manager Nils Bentsen assigned one of his highest-ranking underlings to oversee the city's energetic enforcement and regulation regime relating to the commercial cannabis delivery companies operating from the city's so-called "green zone." That individual, who no longer works for the city, had developed a taste for some of the products those companies were delivering. In his function as a regulator, he grew what was termed "way too close to certain businesses in

the cannabis industry" while he was, the Sentinel is told "going after others." A circumstance had evolved where that high-ranking Hesperia staff member was "getting free edibles from the cannabis companies he was supposed to regulate." This proved to be highly embarrassing to Bentsen. Those companies providing the Hesperia city employee who was supposed to be regulating them with some of the projects they sold was interpreted, widely, as a form of bribery that had compromised Hesperia city staff and the city's cannabis delivery program.

Though virtually all of the 21 entrepreneurs or companies that have licenses/permits to operate what are referred to as Type M-9, non-storefront retailers and delivery services within Hesperia's so-called "green zone" between Santa Fe Avenue East and I Avenue, and Juniper and Smoke Tree streets along with a few parcels running along I Avenue between Juniper and Lemon streets maintain they are providing a needed service and have gone to tremendous expense to establish their operations, a solid majority of the current city council – Bird, Holland, Gregg and Bennington, who is now the city's mayor, have lost their patience with the city playing host to a bevy of commercial marijuana operations.

Bird said he considered "various forms of drug use are gateways to those more alluring drugs, if you will, that take away life, of which I have seen."

Bird responded to those distributors who asserted that they had made substantial investments to set up delivery businesses in the City of Hesperia who felt that taking away their hard-gained licenses were unfair. "I don't want to put you out of business or out of jobs," Bird said, somewhat inexactly. "Certainly, I am pro-jobs. This should never have been approved in the first place. It should never have been a lure to

you to come and do this in this city in the first place."

On October 18, Bird, Holland, Gregg and Bennington made clear they wanted those marijuana distribution operations out of the city. The only question was how soon they would effectuate that.

An issue was that in addition to paying for permits, the businesses had also paid fees for the city to audit their operations. The council on October 18 struggled to find a way to repeal the licensing program and close out the commercial cannabis businesses engaged in delivery from operations based in Hesperia in a way that was not more advantageous to one or some of the businesses over others. The council did not vote on the proposal to end its permitting of marijuana/cannabis-based product delivery businesses as was originally laid out in the agenda for the October 18, 2022 city council meeting. The council instead considered an alternative measure to allow the program to stay

in place subject to a voter referendum on continuing delivery of cannabis in the city. The council rejected that alternative measure with two votes in favor and three votes in opposition. Ultimately, the council approved by a 4-to-1 vote, with Swanson dissenting, to rescind, as of November 2024, the ordinance allowing marijuana delivery businesses to operate from locations within the city.

At that time, as Senate Bill 1186 prohibits a local jurisdiction from prohibiting marijuana delivery to those with a marijuana prescrip-

tion, Hesperia residents will yet be permitted to purchase and be provided with marijuana from delivery services. Nevertheless, those delivery companies will need to be based outside Hesperia, as such businesses will no longer be permitted to be based in the city, and the "green zone" in Hesperia will become nonoperational.

The council voted to keep the city's tax on delivered medical marijuana at 4 percent for the remainder of the time delivery from businesses based in the city remains legal.
