Supervisors Extend Contract With Chief Executive Officer Snoke To March 2031

Making a commitment that locks San Bernardino County and its taxpayers into an essentially unbreakable arrangement for the next twentieth of a century and beyond the guaranteed tenures of any of its current members, the San Bernardino County Board of Supervisors earlier this month extended County Chief Executive Officer Luther

Snoke's employment contract by more than five years, until 2031.

Snoke, who moved up from the position of county chief operating officer in 2023 to become chief executive officer following the forced departure of Leonard Hernandez as the county top staff member, has cemented a positive relationship with his political masters on the board of supervisors in a little over two years.

Third District Supervisor Dawn Rowe has been chairwoman of the board of supervisors since January 2023. She had been from the outset of her time as board chairwoman highly dependent upon Hernandez for guidance with regard to not just the day-today operations of the county but policy initiatives and the hallmarks of governance during

her chairmanship that were to hopefully be her legacy as a major county politician. The San Bernardino County Charter confers upon the board of supervisors chairperson substantial authority by which the chairperson and the top county staff member, formerly referred to by the title county administrator and now known as the chief executive officer, are almost but not quire

coregents of the county, though the full extent of that power is infrequentlv used.

As it would turn out, fate would bind Rowe and Hernandez together in a way that could not have been predicted ahead of time.

U.S. Justice **Department Joins In With Residents &** The GOP In **Contesting The Legality Of Proposition 50**

The Justice Department on Thursday filed a legal action against Governor Gavin Newsom and Secretary of State Shirley Weber in an effort to intervene and prevent the State of California's newly adopted redistricting plan enacted with the passage of Proposition 50.

If the legal action by

the federal government succeeds, it would obviate the effort by the California Legislature and Governor Newsom to rearrange the boundaries of California's 52 congressional districts in a way that was calculated to produce an outcome in the 2026 mid-presidential election such that five of the 12 Republicans now representing California in Congress would be replaced by Democrats. The cost to California's taxpayers to hold the special Proposition 50 election, which was hastily arranged to be held in what in California is an election off-year after the Democrat-dominated legislature in Sacramento resolved to respond in kind to a similar move in Texas aimed at favoring the GOP. The cost sustained by California taxpayers to hold the Proposition 50 election is estimated at roughly \$282.6 million, which includes the state's administrative costs to schedule and carry out the balloting, along with reimbursement to coun-

China's Cutback On Yttrium Exports Further Incentivizing Mountain Pass Mine Expansion

China's strategic business decision earlier this year to radically restrict the export of the rare earth element yttrium, making a substance necessary in the manufacture of a number of modern, high tech products hard to come by as global supplies of the scarce metal dwindle, is accelerating the comeback of the Mountain Pass Mine, located in the extreme northeast corner of San Bernardino County.

On April 4, 2025, China imposed export controls on scandium. yttrium, samarium, gadolinium, terbium, dysprosium and lutetium, causing significant disruption to global supply chains for industries reliant on those materials.

In the case of yttrium, it is an indispensable component in certain speciality alloys.

A specialty alloy is a metal mixture designed to have specific, enhanced properties, extending to superior strength, corrosion resistance, or heat tolerance generally unavailable in standard alloys. In the case of yttrium, the speciality alloys created from it have application in the aerospace industry, the production of renewable energy, in making semiconductors and in certain types of engines. Thin metal composed of yttrium alloys fashioned into turbine blades is able to function and maintain its integrity in high temperature environments. Yttrium is also a key component in coatings that shield against high temperatures.

Because of the Chinese export restrictions, a shortage in yttrium resulted in an escalation in its cost, whereupon the production of certain products have ground to or toward a halt.

County Treasurer Has Advanced The Needles Unified School District \$2M Since August in the 2024-25 budget

San Bernardino County is bailing the Needles Unified School District out of a \$2,025,764 financial crisis with what is anticipated to be two loans, provided in August and this month, in that amount.

Just as the 2025-2026 school year was to begin, on August 5, 2025, the San Bernardino County Board of Supervisors approved County

Treasurer Ensen Mason making a \$1,274,347 temporary transfer of funds to the Needles Unified School District, after certifying the district had a need for the monetary infusion as a result of a delay of property tax revenues, which apparently came about as a consequence of the inability of a substantial number of homeowners in the impoverished

community being delinquent on paying their

The Needles Unified School District consists of five schools - Chemehuevi Valley Elementary School, Monument Peak School, Needles High School, Needles Middle School and Vista Colorado Elementary School. There are 918 students currently enrolled in schools in the district.

In the 2025, i.e., the 2024-25 school year, the most recent year for which financial figures are available, the district had a planned annual budget of \$19,856,618 in revenues and \$19,361,927 in expenditures.

In recent years, however, the district has had difficulty in meeting its financial goals.

The \$19,856,618 it was scheduled to receive

consisted of \$14,399,934 in state-provided Local Control Funding Formula (LCFF) money, \$2,412,844 is other state funds, \$911,600 in local funds, and \$2,132,240 is federal funds. Proposition 50 was passed by over 64 percent of those participating in the election held on November 4. Snoke, possessed of inherent bureaucratic instincts and acquired governmental managerial infighting skills, was able to smooth over, or at least paper over, the potential rift he had with Rowe. Of note, despite some built-up momentum toward making purges of those within the county ranks who had advanced to high positions of authority under Hernandez perceived by some as being the undeserving beneficiaries of his now-discredited administration, Snoke resisted making any radical changes, keeping most of those in vaunted positions on the county's organizational chart in place. While some degree of discomfiture and low volume grumbling resulted among some midlevel county employees and line workers who had been or at least felt they were victimized by Hernandez's "chosen minions," county operations carried on with fewer hiccups and disruptions than might have otherwise been the case.

Snoke, as well, highly conscious of how Hernandez had utilized semi-sycophancy to ingratiate himself with Rowe, made an effort to reinvent himself as a substitute for his predecessor in making certain she was given every assistance practical to make her come across as diligent and competent in her role chairing the board of supervisors and leading the county.

Since September 2023, Snoke has sought, in the words of a wellplaced individual within the county establishment to "take the rough edges off" the county's operations. This entails, the Sentinel was told, making sure official county action that is taken is acceptable to, in descending order, the board of supervisors, other elected county officials, the "support network" those county officials have accumulated including campaign donors and county contractors who serve as vendors of goods and services to the county, public employee unions, public interest groups who have been politically active and county residents generally. When the contract was extended and renewed in 2015, he was offered the assurance that if he was terminated as county CEO, the county would continue to employ him for the duration of that five-year contract extension as a management consultant.

As scandal overtook Hlawek and the county in 1998, the members of the board of supervisors as it was then composed came to regret the commitment the board had made in contractually obligating the county to keep him in place as CAO. Uffer's contract had not yet ended when the board in 2009 collectively decided it no longer wanted his services and undertook to bring Devereaux in as his suc-Subsequently, cessor. Uffer legally contested his involuntary termination and sued the county, whereupon he obtained a

\$650,000 settlement. The county board of supervisors as it was then composed remained enthusiastic about Devereaux and his performance throughout the entire duration of his original five-year contract, so enthusiastic, in fact, that it triggered the five-year extension option in late 2014 to keep him as the county chief executive officer to 2020. In the November 2014 election, however, Curt Hagman was elected to the Fourth District supervisor's post, replacing Gary Ovitt, the one-time Ontario Mayor who had employed Devereaux as Ontario city manager and who was instrumental in convincing his board colleagues in 2009 and 2010 to lure Devereaux to serve as the county's chief ex-Continued on Page 6

After Almost Four Years, Bunton Out & Feingold In As County Counsel

Tom Bunton has left as San Bernardino County Counsel after serving in the role of the county government's top lawyer for less than four years.

Bunton, who was formerly assistant county counsel with the County of San Diego, assumed the county counsel post in San Bernardino County in January 2022.

The office of county counsel is the county's stable of staff attorneys.

Those manning crucial posts within San Bernardino County government have been thrown into a tizzy over reports, none of which could be confirmed at press time, that County Counsel

have conducted reviews of Snoke's performance as the county chief executive officer. No report of the outcome of those reviews was provided publicly, in keeping with the general policy among governmental entities to consider issues pertaining to governmental personnel to be confidential. The decision to extend Snoke's contract for a period of nearly five years and five months, effective November 1, 2025 through March 28, 2031, spoke louder than shouted words. Under the terms of the contract extension, Snoke is to receive total annual compensation of \$659,017, consisting of a salary of \$451,194 and benefits of \$207,823.

As is naturally and typically the case, the relationship between the board of supervisors and its top governmental executive is at its best at the time of the employment contract being approved. Historically, however, there has, unsurprisingly, been a degree of regret and contretemps when the bonhomie ends and a majority or all of

Tom Bunton is on his way out as the county's top in-house lawyer. Laura Feingold, who was elevated by Bunton to the position of chief assistant county counsel 20 months previously, last month assumed the position of consigliere to the San Bernardino County Board of Supervisors last month.

That seemed to imply that a change in who was to hold the position of county counsel was in the offing, but no official action was announced following that closed session. Officially, at least, Bunton remained as county counsel, though at times during the year, Feingold took his place during open board meetings. Previously, at a meeting of the board on April 1, the supervisors, in a closed session engaged in evaluations of the job performance of both Bunton and County Chief Executive Officer Luther Snoke. When the board emerged from that closed session, there

succeeded him, remaining in place one year, from 2003 to 2004. mercial driver's licenses. The suit says both Pacific Coast states "chose to ignore these standards and authorize illegal immigrants without proper training or the ability to read road signs to drive commercial motor vehicles."

Later in August, the U.S. government stopped issuing worker visas for commercial truck drivers, with Secretary of State Marco Rubio announcing the change was effective immediately.

"The increasing number of foreign drivers operating large tractor-trailer trucks on U.S. roads is endangering American lives and undercutting the livelihoods of American truckers," Rubio stated.

The State Department simultaneously said that the hold was being put in place "in order to conduct a comprehensive and thorough review of screening and vetting protocols used to determine the qualifications for a U.S. visa. As we have seen with recent deadly accidents, foreign truckers can pose risks to American lives, U.S. national security, and foreign policy interests. Ensuring that every driver on our roads meets the highest standards is important to protecting the livelihoods of American truckers and maintaining a secure, resilient supply chain."

California officials, in reaction, said Duffy and other federal officials were overreacting and that positions within America's vast logistics industry such as those of truck driver represented an excellent entrance opportunity for those immigrants seeking to integrate themselves and their families into American society as newcomers to the country.

In September, when the Transportation Department issued an order, which went into effect on September 26, calling upon individual states to rescind the commercial driver's licenses they had issued to non-citizens. In doing so, the department referenced three fatal crashes that federal officials said were caused by immigrant truck drivers.

Under that mandate, only three specific classes of visa holders were to be eligible for commercial driver's licenses. Individual states were also required to verify an applicant's immigration status in a federal database before issuing a license. A commercial license issued in this manner is to remain valid only until the expiration date of the visa.

California disobeyed the federal mandate.

Duffy said the Trans-Department portation had carried out a "spot review" of 145 commercial driving licenses issued to foreigners. Of those, he said, 36 should not have been issued. He said four California commercial driver's licenses issued to foreigners who at the time were in the country legally should no longer be deemed valid, since those four drivers' work permits were expired, in at least three cases, more than two years after those expirations, while the truck drivers yet remain in the country illegally. That those individuals were driving trucks and routinely violating federal law should be a cause for concern, including over whether those drivers are flouting traffic laws in multiple states with the same frequency with which they are disobeying federal immigration law, Duffy said. Duffy imposed a \$40 million penalty on California for not complying with the English language literacy requirement for truckers. He gave California 30 days to come up with a plan to comply with the mandate relating to delicensing truckers who did not have visas or face the loss of another \$160 million in annual federal

transportation funding.

"You have 60,000 people on the roads who shouldn't have licenses," Duffy said. "They're driving fuel tankers, they're driving school buses, and we have seen some of the crashes on American roadways that come from these people who shouldn't have these licenses."

California officials took umbrage at Duffy's statements and suggestions, characterizing them and him as "racist" and "xenophobic."

21-year-old Singh was at the wheel of a semi-truck barreling westbound on the 10 Freeway in the number four lane west of the 15 Freeway. The dashcam recovered from the Freightliner's cab shows he did not brake at all and ran into the back of and obliterated a white Kia Sorento that had been at a full stop for several seconds before the impact and continued with considerable force into the back of a white pickup truck, which careened to the left as the Freightliner continued unabated into the back of another semi-tractorpulled trailer, the rear of which momentarily lifted into the air upon impact. The only somewhat-diminished mentum of the Freightliner carried it forward as it careened to the right across two lanes of traffic, where it ran into the front of a disabled tractor connected to a long flatbed trailer and the back of the service truck in front of the disabled tractor that were in place on the shoulder of the freeway. The disabled tractor's front hood was draped open forward and appeared to have been clipped and destroyed along with major elements of the truck's engine in the collision. A man engaged in repairing the disabled truck was severely injured as a result. Both passengers in the Sorrento were killed and pronounced dead at the scene. The driver of a Toyota Tacoma severely injured in the crash was transported to a hospital,

A 43-year-old driver

where he died.

of a Dodge Avenger sustained major injuries, while a 57-year-old passenger in a Chevrolet 2500 had a minor injury, according to the California Highway Patrol.

Singh survived the crash with only a minor contusion. Based not only on an objective assessment of his condition after the crash but on the analysis of the dashcam footage, Singh was arrested and charged with driving under the influence, as well as with three counts of vehicular manslaughter.

In the intervening time, toxicology sults from an analysis of blood drown from Singh demonstrated the presence of no drugs, alcohol or any type of intoxicants in his system. The driving under the influence counts were dropped, but the San Bernardino County District Attorney's Office is pressing forward with the three aforementioned counts of manslaughter in addition to three counts of VC23558-E: causing bodily injury or death; and two counts of PC12022.7(A)-E: great bodily injury on a per-

During his first court appearance, it was revealed that Singh was in need of a Punjabi translator for his next court appearance. This was taken as an indication that his skill with English was insufficient to have allowed him to read the California Driver

Handbook.

Singh in 2022 came to the United States illegally, entering through Mexico. He was an unregistered alien and went to work that year as a truck driver, despite his age and that he was undocumented. He subsequently applied for asylum, but was yet an unregistered alien.

The federal government under Donald Trump and the State of California under Gavin Newsom engaged in a round of fingerpointing over Singh.

The Department of Homeland Security maintains Singh entered the United States illegally during the Joseph Biden administration and was undeterred. Federal officials say he was able to obtain employment authorization documents and a REAL ID in part on the basis of the commercial carriers license issued to him by the State of California. The Trump Administration further asserts that the State of California violated federal law by allowing Singh's license to perpetuate in the face of tightening federal regulations which should have terminated is ability to operate a semi-truck and trailer. In June, California issued Singh a restricted, non-domiciled commercial driver's license with a "K" restriction, limiting his driving to within California. When he turned 21 in October, just days before the October 21 collision, the K restriction was lifted.

California officials faulted the Trump Administration for extending Singh's work authorization, but said nothing about the Biden Administration's initial issuance of that authorization. California insisted that it had complied with instructions issued by the U.S. Department of Homeland Security pertaining to issuing commercial driving licenses to noncitizens.

This week, Wednesday, November 12, California officials announced the California Department of Motor Vehicles will revoke 17,000 commercial driver's licenses held by immigrants. Authorities said the action was being taken after it was determined the expiration dates on the licenses were later than the dates the drivers were legally permitted to remain in the United States.

Without saying so explicitly, the action by California appeared to be an acknowledgment of the state's culpability in having issued the licenses to ranting licenses to, Harjinder Singh, who killed three people in the August Uturn incident in Florida, and Jashanpreet Singh, whose operation of the Freightliner on October

in Ontario on October 21 killed another three people.

Duffy, in reaction, on Wednesday said California's action in revoking the 17,000 licenses was tacitly acknowledging the state acted improperly despite its previous denials of having done so.

"After weeks claiming they did nothing wrong, Gavin Newsom and California have been caught red-handed," Duffy said. "Now that we've exposed their lies, 17,000 illegally issued trucking licenses are being revoked. This is just the tip of iceberg. My team will continue to force California to prove they have removed every illegal immigrant from behind the wheel of semitrucks and school buses."

Duffy pointed out that California officials took the corrective action only after he had made the threat to withhold transportation funds.

Governor Newsom's office could not resist accusing federal officials with being responsible for the shortcomings in applying the law relating to foreign truck drivers, stretching the facts and using a modicum of hyperbole along the way.

The drivers whose licenses California is revoking, the governor's office said, had been granted work authorizations by the federal government. It avoided stating that the federal work permits in most cases were predicated upon the state-issued commercial driver's licenses or that a significant number of the work permits had been issued by the Biden Administration.

Queried as to why the licenses were being rescinded, the governor's office said the Department of Motor Vehicles was taking the action as part of a state law enforcement effort. When it was pointed out that many of the expiration dates now being enforced were more than one year, two years and three years past, the governor's office's spokesman, Brandon Richards Continued on Page 7

stricted to a duration of four years or a period no longer than the current terms of the supervisors then in office.

Despite the repeated experience of past boards of supervisors and the current one which were so enthusiastic about engaging the services of Hlawek, Uffer, Devereaux, Smith, McBride and Hernandez only to reappraise that commitment at a later date, the current board, consisting of Rowe, Hagman, Paul Cook, Joe Baca Jr and Jesse Armendarez, earlier this month felt sufficiently confident in Snoke to not only bind the county and themselves to him until March 2031, but saddle those future members of the board of supervisors who may succeed them with Snoke as well. grew testy. He said the law in question was a state stature, not a federal law and its enforcement had nothing to do with federal pressure.

Duffy pointed out that California was not will-fully complying with the federal rules and mandates but doing so only because of the threat that it would forego another \$160 million in federal funding if it didn't ensure that those with commercial licenses had met the requirements to remain in the country.

Richards disputed that, saying the state was

taking the action unilaterally, without any regard to the federal action or proposed action.

"Once again, the Sean 'Road Rules' Duffy fails to share the truth — spreading easily disproven falsehoods in a sad and desperate attempt to please his dear leader," Richards said.

Under the new federal rules put in place in September, at least 180,000 of the 639,000 noncitizens who have commercial licenses would remain qualified to retain them. Those licenses could be issued

Bunton was provided with an annual salary of \$346,497.76, in addition to which he was provided with \$27,354.34 in perquisites and pay add-ons and \$150,505.54 in benefits for a total annual compensation of

\$524,357.64. His 24 years of employment as a public official entitles him to a pension calculated at 3 percent time each of the 24 years he was a public employee, or 72 percent, of his highest annual salary, that is \$249,478.38 every year for the rest of his life. That pension is subject to a 3 percent maximum cost of living increase each year. That pension is to be paid by both San Bernardino County and San Diego County. Upon his death, his wife will be eligible to continue to draw a beneficiary pension equal to one-half his full pension. It is expected that Bunton's consummate professionalism and adherence to the principles of his profession mean that the fashion in which he comported himself while in the role of county counsel - skillfully purchasing the silence of so many top tier county employees when they made their exodus from the county – he will likewise take his knowledge with regard to many of the dark, darker and darkest secrets pertaining to graft encrusted San Bernardino County government to the grave.

over the preceding two days.

The closest deadly competitor to the I-15's 80 fatalities was the I-10 Freeway in Maricopa County in Arizona, with 57 deaths. The I-10 Freeway in San Bernardino County's neighbor to the south, Riverside County, captured the dubious

third-place prize, with 54 deaths.

San Bernardino County managed to score another place on the traffic fatality registry, as the I-10 in San Bernardino County ended up in a seven-way tie for 41st on the list, with 26 motorists who met his or her end there.

The I-15's status as not just a long-distance means of travel but a commuter route for those living in the many of the cities, towns and communities between the Cajon Pass and Barstow, where there are weekday rush hours in the morning and night as residents there commute to and from work in the greater Los Angeles metropolitan area, contribute to the overall problem. The differing attitudinal, awareness and patience factors between drivers familiar with the routes they take every day and those setting out or returning from Sin City revelry can prove problematic on the highway, where the goal is to reach or exceed 60 miles per hour and maintain that momentum.

two years tapping into Mountain Pass's rich deposits. Seeing that the United States was once again on an arc toward rare earth independence, Chinese companies, subsidized by the Communist Chinese government, increased the output of their mines and created a glut of rare earths on the world market, driving prices downward. By 2015, Molycorp was unable to sell its product at a price that matched or exceeded its production costs nor defray the interest let alone the principal on the debt it had taken on in the modernization of the mine and purchasing its accompanying processing equipment. Molycorp declared bankruptcy, and in July 2017, the mine and its equipment were acquired by a Chinese-led consortium. The mine remained shuttered as the Chinese solidified their dominance of the worldwide rare earth production industry. Despite the consid-

eration that the Mountain Pass Mine during this time was not producing a profit, in moves that were motivated, perhaps, as much or more by patriotic sentiment than mercenary intent, Chicago based JHL Capital Group and New York City-based QVT Financial and its chief executive officer, James Litinsky, in late 2017 became involved in the holding company controlling the mine property, which was redubbed MP Materials. By 2021, OVT, JHL and Litinsky emerged as the three primary shareholders in MP Materials, such that the primary shareholder in the mine, Shenghe Resources, had its interest in the enterprise reduced to 7.7 percent. In recent years, the mine has again begun production, and is currently responsible for roughly 7-to-11 percent of the rare earth minerals being produced globally. On April 4, 2025, China imposed export controls on scandium, yttrium, samarium, gadolinium, terbium, dysprosium and lutetium. In a reaction to that move, the U.S. Department, Defense

since renamed the Department of War, in July acquired \$400 million in MP Materials preferred stock, giving the Pentagon a 15 percent stake in the company. The acquisition was accompanied by an announcement that MP Materials would accelerate the production of rare earth metals and beef up the domestic supply chain, thereby reducing dependence on foreign sources. Last month, on October 9, China's Commerce Ministry intensified the measures taken in April by adding holmium, erbium, thulium, europium and ytterbium to the list of elements subject to export restrictions.

Under China's rules for the export of rare earth minerals, exporters must endure a several-months long process of obtaining licensing from two separate ministries in Beijing, after which government officials will permit only relatively small quantities to be processed for shipment before they are released. China puts a priority on its domestic users of rare earths, such that any pending orders from Chinese companies that come in are filled processing facilities. first before any foreign requests for the substances that come in or any that have previously been registered.

As the issues relating to the availability of yttrium and other rare earth metals have not been resolved, the reliable flow of the critical metals into the United States virtually discontinued, the Department of War and MP Materials have quietly accelerated improvements and expansion of the Mountain Pass mining facility, including

In recent years to the

present, all yttrium being used in the United States came from and still comes from foreign sources, with China accounting for 93 percent of that total. The U.S. imported an estimated 470 tons of yttrium products in 2024, according to the United States Geological Survey.

The Mountain Pass Mine has significant yttrium reserves. Nevertheless, is until recently, yttrium was not directly mined there but yielded as a byproduct of its

mining operations concentrating on neodymium and praseodymium. Any raw ore containing yttrium was previously sent out of the county for processing. At present, neither Mountain Pass nor any other processing plant in the United States has a commercial scale yttrium separating facility.

The Sentinel is informed that in conjunction with the Department of War, a crash program to construct such a facility is ongoing at Mountain Pass.

She spent five years defending San Bernardino County and other related governmental entities. In November 2020, while Blakemore Michelle was county council, Feingold was promoted to a supervising deputy county counsel. Her litigative ability made an impression on Bunton, who three months after becoming county counsel, promoted Feingold to the position of principal assistant county counsel, in which capacity she managed a team of 12 civil litigators and grew the in-house workers' compensation team to four attorneys, while supervising the handling of roughly 400 cases against the county being handled by in-house and outside counsel.

In February 2024, she was made the chief assistant county counsel, overseeing all litigation filed by or against the county or other related governmental entities. In

that role she advised seven county departments.

Feingold fits well within the San Bernardino County scheme of governance. In 2018, San Bernardino county conferred upon her the Public Service Recognition Award for Excellence and in 2023, she was provided with the Dwight Herr Perpetual Award for Outstanding Appellate Practice issued by the County Counsels' Association of California.
