Big Bear Lake Residents Resist City Blindsiding Them With Neighborhood Trash Site

Little more than a fortnight after Big Bear Lake officials blindsided those living within one of the city's residential districts by undertaking the construction of a garbage dump in their neighborhood, residents have struck back, hitting the city manager and senior city administrators with a series of moves they did not anticipate.

Over the weekend of October 11/12, word was spreading among a handful of residents in Big Bear Lake that the city was closing out its Clean Bear Site #2, located at 39690 Big Bear Boulevard, and was going to replace it with one to be sited on two lots owned by the city near the corner of Lark and Cienega roads, adjacent to an existing residential neighborhood.

The Clean Bear program in the City of Big Bear Lake provides drop-off locations for residents and tourists that is tenants and guests of owners of residential properties within the city who cannot use curbside trash service. The sites accept household refuse, recycling, green/ yard waste, pine needles, E-waste and ashes.

That the city properties adjoining Lark and Cienega roads was jarring to those who lived in the neighborhood, which included the aforementioned Lark Road and Cienega Road, as well as Cienega Court, Moab Lane and the area around the Sacred Heart Camp and Retreat. Residents of the area had not been alerted to any items on the city's planning commission and city council agendas referencing development projects in the area or mention of an alteration of the city's zoning maps or codes that would have presaged development in the general or specific area. Singh Crash **Proving To** Be A Double Whammy For San Bernardino **County**

Bernardino San County and its 24 municipal jurisdictions are on the brink of suffering a second heavy blow as the result of Jashanpreet Singh's irresponsible wielding of the Freightliner tractor and trailer he was hauling on October 21.

That day, as the 21-year-old Singh was at the wheel of the semitruck barreling westbound on the 10 Freeway in the number four lane west of the 15 Freeway, he did not brake at all and ran into the back of and obliterated a white Kia Sorento that had been at a full stop for several seconds before the impact and continued with considerable force into the back of a white pickup truck, which careened to the left as the Freightliner continued unabated into the back of another semi-tractorpulled trailer, the rear of which momentarily lifted into the air upon impact. The only somewhat-diminished mentum of the Freightliner carried it forward as it careened to the right across two lanes of traffic where it ran into the front of a disabled tractor connected to a long flatbed trailer and the back of the service truck in front of the disabled tractor that were in place on the shoulder of the freeway. The disabled tractor's front hood was draped open forward and appeared to have been clipped and destroyed along with major elements of the

Proposition 50 was drafted by Democratic Governor Gavin Newsom with input from at least seven other Democratic officeholders and their advisors. No Republicans were involved in framing the proposition. It calls for a one-time suspension the authority of the state's independent redistricting commission, which was established with the passage of Proposition 20 in 2010, to instead adopt a map drawn by the current state legislature. The California legislature, which meets at the statehouse in Sacramento, consists of the upper legislative house, the California Senate, and the lower legislative house, the California Assembly. A supermajority

– more than two-thirds – of the California Senate, are Democrats, consisting of 30 of the body's 40 members. Likewise, the Assembly is overwhelmingly dominated by the Democratic Party, with which 60 of its members are affiliated, while 20 of its 80 total seats are held by Republicans.

California, the most populous of the nation's 50 states, is responsible for electing 52 of the 435 members of the U.S. House of Representatives, who meet at the Capitol Building in Washington, D.C. At present, Democrats lopsidedly outnumber Republicans in California's 52-member Congressional delegation 43-to-9. That is a reflection of the degree to which California leans leftward politi-

On October 28, Ciulla responded by sending a letter via email to both Tinker and Big Bear City Manager Eric Sund, stating in the body of the email that Sund, Tinker and other city officials should deem him to be writing "On behalf of myself and other concerned residents in the area."

While thanking Tinker for her October 27 email, Ciulla lamented that "far from clarifying the city's intent, confirms that the city's current actions are procedurally improper and legally void. The California Department of Motor Vehicles in response to the Sentinel's inquiries was vague as to Singh's status as a licensed commercial driver. With regard to how Singh, with his limited skills in English and inability to decipher the California Driver Handbook or certain road signs, was able to obtain commercial licensing, the Sentinel was referred to the California Highway Patrol. California Highway Patrol Spokesman Rodrigo Jimenez told the Sentinel he could not answer questions with regard to Singh's licensing status at this time.

The Sentinel's independent examination of the record relating to Singh, whose residence is in Yuba City, indicates that he exploited gaps and inconsistencies be-

The city's actions are unlawful, Ciulla contended, because a temporary use permit in this circumstance is legally invalid because "The subject parcels are zoned R-1 (Single-Family Residential) [and] er the Big Bear Lake Development Code (e.g., Table 17.25.030.A), a 'public works staging area' or 'waste facility' is not a permitted or conditionally permitted use. It is, by omission, a prohibited use."

Furthermore, Ciulla's missive holds that "The temporary use permit ordinance (Section 17.03.290) requires the city to make a finding that the temporary use is 'compatible with surrounding land uses' [and] It is a legal impossibility for an administrative body to 'find' a use to be 'compatible' when the city council, in its legislative capacity, has already deemed that exact use incompatible by prohibiting it in the zoning code. The temporary use permit is a legal fiction that cannot authorize a prohibited use."

In moving to construct a trash dump or trash holding facility, temporary or permanent, on property zoned solely for residential use and proximate to existing residential uses, according to Ciulla, violates both the City of Big Bear lake's development code and State of California's environmental law.

In pursuing the project, Ciulla contended, the city knowingly misapplied its conditional use permitting process. "[Y]our suggestion that a permanent facility can be authorized by a 'conditional use permit process' is a demonstrable misrepresentation of the development code. A conditional use permit is an administrative tool that can only be used for uses already listed as conditional in the R-1 zone. A waste facility is not. The city's correct zone for this industrial use is the C-5 (Commercial-Industrial) zone, which explicitly lists 'waste management facilities, and utility yards' as a permitted use. The city is fully aware that its only legal path to place a

C-5 use on R-1 land is via

a high-barrier, legislative general plan amendment and zone change. The city's claim of a 'conditional use permit' path appears to be an intentional effort to bypass this required, more rigorous, and more public legislative process."

Ciulla asserted that "[T]he city is in clear violation of the California Environmental Quality Act."

Under the California Environmental Quality Act, an examination of the environmental impacts of a project must be made. Some discretion is left to the governmental decision-making body that oversees land use issues and possesses approval and/or denial authority over a development project as to what type of analysis of the environmental issues is to be carried out and what mitigations of the impacts are to be required. A simple negative declaration is the least exacting type of development impact assessments and a mitigated negative declaration is the secondleast stringent type of development impact as-

illegally at the age of 17 and later applied for asylum status to allow him to remain in the United States despite having violated the law by coming across the Mexican border into California undocumented.

Shortly after he arrived, he began driving large two axle vehicles, including stake bed and box trucks. It appears that he was doing so without having first obtained a standard, noncommercial Class C license, the basic licensure for all drivers in California. Without being registered as an alien present in the country, he thereafter obtained a standard Class C license. It was during this time that he first began driving large commercial vehicles. He was doing so without having a commercial Class B license, which applies to 3-axle vehicles weighing over 6,000 pounds or two-axle vehicles with a gross vehicular weight of up to 10,000 pounds and without having a Class A license, applying to any single vehicle with a gross vehicle weight rating of more than 10,000 pounds and semi-trucks.

Ultimately, by 2024, the State of California issued him a Class A license, with which he was authorized to drive semi-tractor's pulling trailers. It is not clear how he was able to obtain that license after having, on numerous occasions, driven vehicles he was not licensed to operate.

San Bernardino County Superiror Court records show that on ten occasions in the last two-and-a-half years he received citations while he was operating a big rig. Two of those matters were dismissed, he was convicted or entered guilty pleas on five and three have yet to be fully

adjudicated.

At the Fontana Courthouse, he was acquitted of a charge of violating VC22348(C)-I: operating a vehicle out of its designated lane that was filed against him on April 26, 2023.

On July 11, 2023, September 10, 2024 and October 8, 2024, Singh was charged with violating VC22406(A)-I, exceeding the maximum speed allowable for trucks. In each case he appeared at the Needles Courthouse to answer those charges and was ultimately convicted

On October 7, 2024, he was charged with violating VC21460(A)-I, riding left of a double yellow line. He answered that charge at the Joshua Tree Courthouse and was acquitted.

On February 27, 2025 he was once more charged with speeding. He appeared in Needles Traffic Court to answer that charge, entering a not guilty plea, and the matter is yet to adjudicated.

On April 18, 2025, he was again charged with exceeding the maximum speed allowable for trucks. He was convicted of those charges in Needles Traffic Court. s

On May 1, 2025 and again on May 26, 2025, he was charged with speeding while operating a commercial vehicle. Both of those matters are being heard in Needles Traffic Court. He is due for trial on the May 1 charge on December 1, 2025 and is to face trial on the second charge on February 17, 2026.

On July 10, he was issued a citation for not having an operator's license, driving a vehicle for which the registration fees were delinquent and not having evidence of insurance coverage. He failed to appear on that matter at the Fontana Courthouse on October 10 of this year. No bench warrant was issued, but a courtesy notice was sent to his home in Yuba City.

In June 2025, a mere four months ago, at the age of 20, Singh obtained a "restricted, nondomiciled commercial drivers license" with a "K" restriction from the California Department of Motor Vehicles, despite his lack of English language skill and without have demonstrated his understanding of common road signs. The K restriction limited his licensure to driving in-

In July, as part of a policy change initiated by the Donald Trump Administration, the federal government began pressing states which had issued commercial driving licenses to individuals in who were undocumented aliens or otherwise in the county illegally to rescind those licenses.

On September 26, the federal government tightened truck driving licensing requirements for all non-U.S. citizens. That policy change included suspending as of that date the issuance of non-domiciled commercial driving licenses. Singh's commercial drivers license was supposed to be rescinded at that time. The State of California, however, failed to comply with order from the federal government, doing so in some measure because of both Governor Gavin Newsom's and the Democrat-dominated California State Legislature's declared intention to resist the Trump Administration's immigration policy. Had the State of California and the California Department of Motor Vehicles complied with the federal order, Singh's commercial drivers license would have been rescinded, ef-

fective September 26.

On October 15, Singh turned 21. At that point, California, through its Department of Motor Vehicles, automatically eliminated the "K" restriction from his license, such that he was no longer limited to driving in-state.

When the Sentinel

queried the Department of Motor Vehicles about whom or what company Jashanpreet Singh was driving for when he was involved in the October 21 fatal collision, what cargo he was hauling at the time of the accident, what substance he was under the influence of at the time of the accident and whether he was licensed to be a commercial driver, the Sentinel was referred to the California Highway Patrol. California Highway Patrol Spokesman Rodrigo Jimenez said he was not authorized to release owner/company information and that he did not have information about what Singh was hauling. Jimenez said that Singh "was arrested for driving under the influence of drugs. We cannot specify [what substance he was under the influence of] due to the ongoing investigation."

On Sunday, October 26, U.S. Transportation Secretary Sean Duffy, indicating he had been pushed to extremity by what had occurred on the I-10 Freeway in Ontario on October 21, said he was preparing to revoke millions in federal funds for California because the state is illegally issuing commercial driver's

licenses to noncitizens.

According to Duffy, California Governor Gavin Newsom has proven intransigent in the face of Department of Transportation rules requiring all 50 states to stop issuing such licenses and review those already issued.

"I am about to pull \$160 million from California," Duffy said. "We also have the option of pulling California's ability to issue commercial driver's licenses."

Newsom's office said it would have no comment with regard to what a spokesman called Duffy's "unjustifiable threat."

The California Department of Motor Vehicles did not respond to requests as to why it had not delicensed Singh in compliance with the September 26 federal order.

The October 21 collision involving Jashanpreet Singh was not the first time California's lax licensing of foreign truck drivers has been raised as a national safety issue.

In August, three people were killed when the driver of a semi-truck, Harjinder Singh, attempted to perform an illegal U-turn on the Florida Turnpike in St. Lucie County. Harjinder Singh, who is not believed to be of blood relation to Jashanpreet Singh, like Jashanpreet Singh entered the U.S. illegally and obtained a commercial driver's license from California and one from the State of Washington, according to the U.S. Marshals office.

A nationwide commercial driver's license audit by the federal government initiated the following week determined that licenses were issued improperly in California, Colorado, Pennsylvania, South Dakota, Texas and Washington.

Subsequently, the State of Florida sued the states of California and Washington over their issuance of commercial drivers licenses to Harjinder Singh. Florida's attorney general, Florida Attorney General James Uthmeier, has broadened that legal action

to include a petition to the U.S. Supreme Court to to prevent California from issuing commercial driver's licenses to those in the country illegally, asserting it is a matter of public safety.

The lawsuit accuses California and Washington of refusing to comply with federal safety and immigration-status requirements relating to the issuance of commercial driver's licenses. The suit says both Pacific Coast states "chose to ignore these standards and authorize illegal immigrants without proper training or the ability to read road signs to drive commercial motor vehicles."

In August, the U.S. government stopped issuing worker visas for commercial truck drivers, with Secretary of State Marco Rubio announcing the change was effective immediately.

"The increasing number of foreign drivers operating large tractor-trailer trucks on U.S. roads is endangering American lives and undercutting the livelihoods of American truckers," Rubio stated.

The State Department simultaneously said that the hold was being put in place "in order to conduct a comprehensive and thorough review of screening and vetting protocols used to determine the qualifications for a U.S. visa. As we have seen with recent deadly accidents, foreign truckers can pose risks to American lives, U.S. national security, and foreign policy interests. Ensuring that every driver on our roads meets the highest standards is important to protecting the livelihoods of American truckers and maintaining a secure, resilient supply chain."

Rubio's initiative came less than three months after the Trump administration, through the Transportation Department, took steps to enforce the requirement that truckers speak and read English proficiently. According to the Transportation Department, achieving minimal liter-

ones fired by deputies positioned outside the bystanders' line of sight. At some point, Saldivar either exited the condominium from an alternate exit at the back of the building or found his way into the enclosure of another unit and from there made his way to his motorcycle, and quickly rumbled away.

He was spotted by the deputies, who gave chase up Day Creek Boulevard. He then made his way onto the 210 Freeway headed west. There ensued a chase, with the motorcycle far ahead of the pack, accelerating to a speed well in excess of 120 miles per hour and, at one point for a short distance, reaching nearly 150 miles per hour, as Saldivar, wearing a backpack and dark helmet and visor, blasted past cars traveling at 55, 60, 65, and 70 miles per hour in a blur as if they were standing still. Dethe distance he was able to rapidly put between himself and his immediate pursuers and the risk he was willing to take, when he did not make a quick exit from the freeway and succeed in finding visual anonymity somewhere in urban landscape elsewhere in Rancho Cucamonga or Upland, Saldivar found himself being trailed and seen, by at first a handful of patrol units from the sheriff's department and the Upland Police Department and then dozens, which became scores of various law agencies, enforcement including the Highway Patrol, the Claremont Police Department, the La Verne Police Department, the Los Angeles Department Sheriff's and the Azusa Police Department, all of which were on the ground. In short order, law enforcement agency and then television/radio news helicopters were overhead, charting and documenting, on video, his movements and location in real time.

Heading toward the heart of the Los Angeles megalopolis, he exited from the freeway, turned south and then abruptly got back onto the freeway, heading east. He sped along, perhaps contemplating reaching the more familiar turf of San Bernardino where he could ditch those who were after him.

At one point, after safely outdistancing his closest pursuers, he had slowed down to a respectable 68-to 70 miles per hour in the Diamond/ High-Occupancy-Vehicle inner lane, seemingly trying to blend in with the traffic around him. as if he could somehow lose himself among the other vehicles. As if out of nowhere, a California Highway motorcycle moved up close behind him and then went to his left so that the Highway Patrol cycle's front wheel was nearly even with

Saldivar's back wheel. That jolted Saldivar, who glanced back to his left as if to confirm what he had seen in his mirror or out of the corner of his eye, at which point he accelerated his machine up to somewhere in the vicinity of 85 miles per hour once again.

The fleeting proximity of the Highway Patrol motorbike served as something of a wakeup call to Saldivar, it seemed and once he was a safe distance ahead of the Highway Patrolman, he dropped down took both hands off the handlebars as he began fidgeting around and pulled a gun out of his backpack and his pockets, and appeared to be putting bullets in its chamber.

Near the Campus Avenue exit of the east-bound 210 shortly after 1:30 p.m. Saldivar and his motorcycle were about to pass on the left, as had been the case several hundred times over the previous fifteen minutes or so, another slower-moving vehicle in the Diamond Lane, this time a gray Toyota. At

the wheel of the Toyota was an off-duty San Bernardino County Sheriff's Department narcotics division detective.

As the motorcycle closed the distance behind it, the Toyota made an at first subtle drift to its left followed by somewhat sharper movement across yellow line separating the Diamond Lane from the inner freeway shoulder. Saldiver reacted to adjust, but at the speed he was traveling at that point – about 68 miles per hour – not in time to avoid having the motorcycle's front tire plunge into the Toyota's driver's side of the car. The impact launched Saldivar in an arc headed over the hood of the car as the driver deftly steered right, avoiding hitting Saldivar who flipped in mid-air and landed on his back on the shoulder of the road.

It appeared that two firearms that were in the backpack fell out onto the pavement, when Saldivar's arms came out of the rucksack's straps as he was tumbling before coming into contact with the ground.

The motorcycle, meanwhile, careened more sharply leftward than the rider it had now lost, hitting into the retaining while between the eastbound and westbound lanes of the freeway, then bouncing and flipping to come down, temporarily, on Salvidar, as both the bike's and the man's momentum carried them eastward.

Within three minutes, at least 21 law enforcement vehicles were parked across four of the lanes west and behind where Saldivar came to rest. Several officers swarmed him, but he was incapacitated by the crash and the injuries he had sustained. An overhead video showed that eventually Saldivar was sitting up as paramedics administered to him and he was loaded onto a stretcher and transported from the crash site on the 210 to a hospital via helicopter.

Saldivar is to be taken into custody once he is medically cleared for release.

immigration law, Duffy said. He gave California 30 days to come up with a plan to comply or lose funding.

legality while explaining that the city was the project proponent that had utilized its authority to defy the law and calling for citizen protest and counteraction in response.

manifestations of these were a letter writing campaign aimed at elected city officials and City Hall staff to impress on them the dim view residents have taken with regard to the project, as well as a telephone call blitz to convince city officials they should rethink what they are doing. There is now an effort underway to prompt citizen participation at the Wednesday, November 5 Big Bear Lake Planning Commission meeting to be held at the unusual time of 1:15 p.m. and the regular city council meeting scheduled for Thursday, November 6 at 4 p.m.

City officials were as taken aback by the resident reaction and Ciulla's letter as the residents were thunderstruck by the city's clearing of the property, removal of trees, grading, the pouring of base and initiation

of construction activity on the lot at the confluence of Lark and Cienega Roads.

Indeed, Sund came across as having been put into a state of paralysis by the developing resistance to the project.

The Sentinel this week made multiple attempts to reach him at his office at City Hall to no avail. Thereafter, it sent an email to both his personal and city email address. In the email the Sentinel sought to determine if the residents' widespread perception that the parcel owned by the city in the environs of the 39000 block of Lark Road was being altered for the purpose of holding trash, i.e., essentially replacing the function of the current facility at 39690 Big Bear Boulevard, whether there were some inaccuracies in the presumptions of the residents of that neighborhood and whether he could provide the Sentinel's readership a concise, cogent and accurate size-up of what is actually occurring.

The Sentinel inquired of Sund as to whether he could refute the residents' contention that the activity taking place on the lot at Lark and Cienega roads and what was to be established there is incompatible with the nature and tenor

of their neighborhood and the predominantly residential uses in that neck of the woods. The Sentinel noted the residents' assertion that the use of the property in question is confined, by law, to residential use only, and that the city cannot legally rezone the property and it cannot develop the property for anything other than residential use. Moreover, it was pointed out that the residents specifically objected, in the most adamant of terms, that the site in question could be transformed into a trash dump, trash holding station or trash transfer station. The Sentinel asked if the residents were right about what is going onto the property and if not what the property is going to become. The Sentinel inquired whether the city's intended use of the property matches the zoning and, if the use does not match the zoning, what process of adaptation was made or is to be made to allow a nonresidential use on that property. The Sentinel refer-

nhe Sentinel referenced the widespread perception on the part of the residents living proximate to the project that the city blindsided them by initiating the project without any warning. The Sentinel asked if the project

or the alteration of the Clean Bear Program was previewed to the public and then discussed in a public hearing and voted upon, either by the city council or the planning commission. The Sentinel requested that Sund cite those meeting dates, agendas and minutes that document the proper notification of the project and its approval took place. The Sentinel asked Sund to explicate how it is that those most directly impacted by this project or the Clean Bear Program alteration

learned of it only after they detected physical activity/preparations on the property in question. The Sentinel asked Sund what his response is to the complaints and contentions of those living in the Cienega Road/ Lark Road neighborhood that they were not afforded the opportunity to offer their input with regard to the project/ program alteration before the city committed to proceeding with it and if it is now his belief that the City of Big Bear Lake got ahead of itself in moving forward with a project/program that was not given adequate citizen review. The Sentinel offered Sund the opportunity to explain how the activity the city is undertaking on the property at the juncture of Cienega and Lark roads falls entirely within the rights of the city as a municipal agency and will be of betterment to the entire community.

Sund made no response to the *Sentinel's* email.

The first warrant was served at 6:00 a.m., in the 4900 block of Mason Street, Southgate. Investigators located a large locked prefabricated room within a body shop, the room contained a large amount of stolen Burlington Northern Santa Fe property.

Evidence from the search warrant led to the issuance and serving two additional search warrants at a residence and business proximate to and virtually across the street from the Mason Street address, within

the 4900 Block of Mason Street in Southgate. Three suspects were contacted and arrested.

Evidence from the three search warrants led investigators to another residence in the 7800 Block of Rose Street in Paramount where a search warrant was authorized and served. Additional stolen Burlington Northern Santa Fe property was located.

Evidence from the search warrant led investigators to a nearby storage facility in the 7000 Block of San Luis Street in Paramount. Two additional search warrants were authored for two storage units where additional Burlington Northern Santa Fe stolen property was located.

Based off information from the previous search

warrants, investigators authored an additional search warrant for another residence in the 14900 Block of Downey Avenue in Paramount. Additional Burlington Northern Santa Fe stolen property was located.

Burlington Northern Santa Fe estimated the recovered property totaled \$2,118,459,20.

Penultimately, all the recovered property was released to Burlington Northern Santa Fe. Eventually, it will be returned to the rightful owners.

Those taken into custody during the operation were Alfredo Santos Reyes, a 34-year-old resident of Southgate; Cesar Martinez, a 41-year-old resident of Southgate; and Jorge Castillo, a 46-year-old resident of Southgate.
