

## Federal Probe Examines Newsom's Vectoring Of Donors To Wife's Charities

The U.S. Justice Department under the Donald Trump Administration has widened a four year-running investigation into Jennifer Siebel Newsom to include her husband, California Governor Gavin Newsom, as well as a host of the governor's donors and political associates, including California Secretary of State Shirley Weber, the *Sentinel* has learned.

The original investigation targeting Siebel Newsom was launched by federal investigators serving under then-President Joseph Biden four years ago but had not matured into a prosecution. Siebel Newsom's proximity to her husband, whose ambition extends to making a run for the U.S. Presidency in 2028, together with suggestions that the couple's accumulation of wealth involves the exploitation

of Newsom's status as the governor of a state with an annual gross domestic product of \$3.39 trillion, has prompted the Trump Administration to undertake scrutiny of a figure who has emerged as one of his more vociferous critics.

At issue in the investigations are donations, both charitable and political to Siebel Newsom's foundations and the governor's campaign fund; how those chari-

table donations have been transformed into roughly \$4.1 million in income to Siebel Newsom, sizable real estate transactions involving the couple; arrearages of over \$400,000 on property taxes that have yet to result in a lien, long ongoing and never redressed political fund reception and handling reporting violations by the Newsom campaign that have never been addressed or resolved by

the California Secretary of State's office, the existence of a reputed "slush fund" said to have been used to cover the lavish lifestyle of California's first couple and how the provision of that money to the governor and his wife might have influenced key governmental decisions in Sacramento.

## AVUSD Board Rewards Colleague's Harping On Financial Discrepancies With Censure

Renee Longshore's reformist efforts with regard to the Apple Valley Unified School District have proven too aggressive for three of her four board colleagues, pushing them to censure here at last week's board meeting.

Longshore was first elected to the board in November 2024. What began as a relatively cordial relationship with the

four other board members – Board President Amanda Buchanan, Maria Okpara, Anita Tucker and Rick Roelle – grew slightly strained over the course of 2025 and then broke into open hostility with Buchanan, Okpara and Rolle earlier this year when the Victorville-based *Victor Valley Daily Press*, the most widely circulated newspaper in Apple Valley,

published an op-ed piece in which she expressed her belief that the district was misprioritizing its spending and she referenced a discrepancy or discrepancies in the district's financial documentation.

Longshore decried the district increasing salaries for and expenditures on the district's super-

visory personnel by 90 percent over the previous six years while teachers and student support staff salaries had grown by 39 percent. She said that both increases were out of keeping with the 57 percent increase in revenue the district had experienced over the same six years.

Longshore stated that budget juggling that relied on reports of unveri-

fied deficit spending and unaccounted for one-time or limited-time infusion of funds provided to the district during the COVID crisis, there \$15,459,155.91, that had been entrusted to the district that had been "lost."

In the *Daily Press* piece, Longshore cited inconsistencies in the district's financial documentation provided to her, other **See P 3**

## Hesperia Lake Fully Reopened Following Repairs To Christmas 2025 Storm Damage

Almost six months after the Christmas 2025 storm that created havoc in many places throughout the High Desert but especially in Hesperia, the Hesperia Recreation and Park District has fully reopened Hesperia Lake Park along with its Val Shearer Arena and Equestrian Center.

The heavy winter deluge was severe.

At Hesperia's subre-

gional water recycling facility, located near the intersection of Maple Avenue and Muscatel Street, where Hesperia's subregional water recycling facility is located, the basin there filled entirely and began overflowing. The wall around the facility failed, sending a violent sheet of water east on Muscatel and north on Maple.

A raging river formed

on Sultana Street, making transit on the road virtually impossible and leaving some motorists at several spots stranded when they attempted to ford it and the water level reached above the car's ignition and exhaust systems.

Similar language - raging rivers - was used to describe sections along both Street water mains. Aspen Street and Pinon

Avenue in the proximity of Olive Street.

The storm did significant damage to recreation and park district facilities, forcing closures to prevent injuries to those using amenities.

Repairs along with restoration work have been proceeding at various locations throughout the the district's various outdoor venues, with the final touches to the

virtually unabated.

On June 16, a team of robbers removed an estimated \$100,000 worth of audio equipment from a train car near Newberry Springs and were in the process of loading it into an enclosed truck when they were interrupted by a sheriff's deputy. The stolen merchandise was recovered and the truck that was being **See P 3**

## Pinon Hills Man Among Failed White House Attack Plan Architects

A San Bernardino County man was among five of the ringleaders in a plot to use explosive-carrying drones to disrupt the UFC cage-fighting event President Donald Trump staged at the White House on Sunday, June 14 and have snipers pick off members of the panicked crowd as they fled from the scene.

Those involved evinced antigovernment sentiments, which in part appeared to be religiously based, and indicated their overriding belief in specific conspiracy theories, according to the U.S. Department of Justice.

No action was taken on June 14 to put the plot into play, as logistics issues plagued some of the would-be actors and the government's reaction prevented certain specific steps that were being planned from being taken. Federal agents recovered firearms from several of the suspects who had communicated with one another both in the open and using encrypted messaging. Those seizures were made as agents served arrest warrants.

The agents were able to obtain further encrypted text messages as a result of the surprise raids. Those messages implicate roughly 20 individuals who were passing between themselves maps, outlines and aerial photographs of the area, as well as referencing the need to secure a "safe house" and map out routes of escape after the attack, documents shared with the media by the U.S. Attorney's Office in Los Angeles show.

of the two charitable foundations created or co-created by Siebel Newsom or her production company prompted the U.S. Attorney's Office in Sacramento to open an investigative file.

Siebel Newsom founded the Representation Project, a non-profit focused on promoting gender equality, challenging gender stereotypes and uplifting and supporting media through media, education and activism in 2011. It began fundraising toward those causes in earnest the following year. In 2019, she cofounded with Olivia Morgan the California Partners Project, a non-profit which works to get more woman onto corporate boards, address the gender pay gap and make technology and media platforms safer for children. Siebel Newsom also owns a production company called Girls Club Entertainment.

From 2012 until 2019, Siebel Newsom was paid, as the director/executive officer of the Representation Project in the neighborhood of \$165,000 to \$205,000 per year, while the organization took in an average of around \$600,000 per year in donations. Since 2020, as the director/executive director of the Representation Project and the driving advocate of the California Partners Project, she has been paid a combined average of \$395,000 a year, while donations to both foundations have approached or exceeded \$1.3 million annually.

The arrangements by which Siebel Newsom is a principal in the non-profit organizations she founded and is paid for her work on its behalf is entirely legal under both

California and federal law. Questions, however, have emerged about the propriety and, indeed, the legality of the contracts her company, Girls Club Entertainment, has for producing films and promotional materials for the Representation Project. Girls Club Entertainment put together a multitude of what were characterized as "gender-focused documentaries," which included *The Mask You Live in*, *Miss Representation*, *The Great American Lie* and *Fair Play*, specifically for the Representation Project, which licensed them. Those materials were distributed to public schools and educational forums and programs under that license. Reportedly, Girls Club Entertainment realized \$1,483,001 on the licensing of the films to schools through the Representation Project alone from 2012 until December 2022. In addition, films produced by Girls Club Entertainment on the same topic and themes – decrying the exploitation of women in the workplace, including a lack of promotion into managerial and administrative positions and roles and a disparity in pay scales favoring men and disadvantaging women – were also licensed by the California Partners Project and provided to both public and private schools in California.

It is a yet untested theory of federal investigators and prosecutors that the contractual arrangements between Girls Club Entertainment and both the Representation Project and the California Partners Project were not arms length transactions and that the Representation Project and the California Partners Project did not conduct a competitive bid before contracting with Girls Club Entertainment for the production of the films, which thereby were sold for and purchased at an inflated rate.

Investigators have also pursued a tangent exploring several examples of Governor Newsom putting the arm on

business owners whose companies have contracts to deliver goods or services to the State of California to make donations to the California Partners Project.

It is the inexplicable inflow of money to the Newsoms that has occurred in anomalous ways and which is seemingly bankrolling a luxurious lifestyle that has also captured the attention of investigators and prosecutors. Both Newsom and Siebel Newsom come from moneyed backgrounds. Newsom's father, William Alfred Newsom III, was an attorney for J. Paul Getty and Getty Oil. Siebel Newsom's father, Kenneth F. Siebel Jr., is a successful investment manager.

In the late 1980s, when he was in his very early twenties, Gavin Newsom was given a substantial boost by Gordon Getty, the son of J. Paul Getty, who over the next several years undertook to invest in ten of Newsom's 12 fledgling business ventures, including PlumpJack Associates L.P., which was registered with the California Secretary of State in May 1991. Newsom and his investors started PlumpJack Winery in 1992, deriving the name from an opera written by Getty.

The PlumpJack Cafe Partners L.P. opened the PlumpJack Café, also on Fillmore Street, in 1993. Thereafter, Newsom and his investors, most prominently Getty, opened other businesses that included the PlumpJack Squaw Valley Inn with a PlumpJack Café in 1994; a Napa Valley winery and the the Balboa Café Bar and Grill in 1995; the PlumpJack Development Fund L.P. in 1996; the MatrixFillmore Bar in 1998; PlumpJack Wines shop in Noe Valley in 1999, PlumpJackSport retail clothing store in Olympic Valley and a second Balboa Café at Squaw Valley in 2000. Subsequently, those operations were expanded to include PlumpJack Winery in Oakville, California, the PlumpJack-owned Cade Winery in

Angwin, California and Airelle Wines Inc.

Newsom's investments included five restaurants and two retail clothing stores and his lowest annual income between 1996 to 2001 was \$429,000. In 2002, the value of his business assets reached \$6.9 million.

Newsom, a 1989 graduate of Santa Clara University, where he earned a Bachelor of Science in political science, supported Willie Brown in his successful 1995 campaign for mayor, volunteering not only as a representative in approaching voters but hosting a private fundraiser at his PlumpJack Café for the former speaker of the Assembly. Brown appointed Newsom to the city's parking and traffic commission in 1996. Newsom was later elected president of the commission. The following year, 1997, Brown appointed him to the San Francisco Board of Supervisors seat vacated by Kevin Shelley.

It was while he was on the board of supervisors, according to investigators, that what are now recognized as silent partners moved into Newsom's orbit and became involved in some of the PlumpJack-affiliated enterprises.

In 2004, when Newsom was elected mayor, he divested himself of share of PlumpJack's San Francisco businesses, while retaining his ownership in the PlumpJack companies outside San Francisco. Prior to moving into the mayoralty, Newsom was at least minimally and in some case more actively involved in the businesses' operations. Upon becoming mayor, he became far more removed from any day-to-day management or even overarching control of those ventures, and was described with regard to virtually of them as being "a partial owner in absentia."

In February 2006, he paid \$2,350,000 to purchase a mansion in San Francisco's Russian Hill neighborhood. In April 2009, after real estate

prices had taken a hit as a consequence of the nationwide mortgage crisis, as Newsom was contemplating a run for California lieutenant governor the following year, he put that home on the market for \$3 million.

In November 2010, Newsom successfully vied for lieutenant governor. In November 2011, while in the capacity of lieutenant governor, Newsom and his wife purchased a home in Kentfield in Marin County, for \$2.225 million from former Tamalpais Bank CEO Mark Garwood.

Newsom spent the eight years from January 2011 to January 2019 as lieutenant governor while Jerry Brown, another Democrat, was governor.

Newsom was elected governor in November 2018, and in 2019 the Newsoms placed the Kentfield home on the market for \$6 million. It sold in 2021 for \$5.9 million.

In 2019, Newsom and his family briefly lived in the California governor's mansion in Sacramento, but vacated that to move into the 12,000-square foot Fair Oaks Mansion 7640 Tobia Way on eight acres beside the American River in the unincorporated Sacramento County area known as the Fair Oaks district on the outskirts of Sacramento.

An LLC registered to Newsom's cousin and business associate, Jeremy Scherer, who is the co-president of PlumpJack, purchased

the Fair Oaks estate for \$3.7 million cash in December 2018, a month after Newsom was first elected governor. In 2019, after Newsom was added as a member of the LLC, Scherer "gifted" the property to his cousin. Newsom's status as a member of the LLC allowed him to avoid a \$4,000 real estate transfer tax.

In January 2020, the Newsoms engaged in a very curious move when they entered into a reverse mortgage on the Fair Oaks estate, receiving a \$2.695 million tax-free payment in the cash-out refinancing.

Traditionally, reverse mortgages were generally considered loans of last resort that served as a safety net for cash-strapped retirees, as conventional wisdom dictated keeping home equity untouched and only borrowing against it in dire emergencies. More recently, financial planners have latched onto reverse mortgages as strategic tools to be used by those who are well off, but that occurs in cases where market volatility or unexpected downturns in the economy might prompt a well-positioned investor to sell off elements of an investment portfolio that might have longer-term profitability than real estate. The Newsoms did not appear to be in panic mode with regard to their assets or holdings in 2020.

Catching the eyes of investigators was that in the paperwork for the \$2.695 million mortgage, there was no

used in the theft damaged and seized, though the criminals involved in the train car break-in, at least temporarily, eluded capture.

According to the sheriff's department, "This incident highlights the ongoing issue of cargo thefts impacting businesses and consumers

alike."

Authorities say there has been a persistent pattern of highly organized thefts involving international criminals targeting railroad cargo cars in San Bernardino County and elsewhere in San Bernardino County going back for more than a year.

According to the Association of American Railroads, "In recent years, organized criminal groups have increasingly targeted the nation's railroads using sophisticated tactics and technology to commit

cargo theft."

Over the last eight to ten months, an intensified crackdown on railroad cargo theft has been pursued by a multitude of agencies and entities, including the San Bernardino County Sheriff's Department and the Burlington Northern Santa Fe Railroad Police as well as the FBI and Department of Homeland Security.

In Southern California in particular, investigators have learned that at least some of the perpetrators have previously succeeded because

they had inside information about railroad company operations.

Railroad industry sources and law enforcement professionals report that a substantial amount of railroad cargo theft takes place as a consequence so-called "inside jobs," that is, with the assistance of those who work with the railroads themselves or as part of the rail infrastructure and support network. Individuals linked to cargo theft rings who have specific knowledge of the placing and timing of the shipment by rail of high-

value goods is a common vulnerability and a major factor in the success of criminals who target rail cars for theft. Railroad police, the sheriff's department, the San Bernardino Police Department, the Colton Police Department, the Rialto Police Department and the FBI have information that organized crime is employing individuals who assume relatively low-ranking and even temporary positions with rail companies or at rail terminals and rail yards to obtain information about what goods are be-

ing transported on which trains and in specific rail cars, together with information about when and where the trains are to remain stationary for an extended period.

Another vulnerability consists of spots where moving trains must slow considerably at curves or bends in the rail line, as is the case at certain spots along and at the bottom of the slope descending from the Cajon Pass near Devore. Trains are obliged to decelerate to navigate the sharp, sweeping curves along *Continued on Page 4*

Republicans emphasize the United States is a republic. Democrats' first characterization of the country is that it is a democracy.

Republicans are the party of corporations. Democrats are the party of labor.

The Republicans promote entrepreneurship. Democrats are unionists.

Republicans perceive taxation as being stifling and a limitation on freedom and growth. Democrats view taxation as a tool that will even the economic playing field and enable government to broaden the provision of public services and engage in social programs to better the community.

Despite the consideration that of Chino Hills' 48,624 registered voters, 16,792 or 34.5 percent of them are registered as Democrats, five more than the 16,784 or 34.5 percent who are registered Republicans, elections there are dominated by Republicans. That is the product of multiple factors. Perhaps the most powerful one is that in excess of 90 percent of those Republicans participate in the electoral

process on a consistent basis, whereas voter turnout among Democrats rarely reaches beyond 60 percent. Moreover, a majority of the city's 11,871 voters or 24.4 percent who have no party affiliation and the 3,007 or 6.1 percent who are members of the American Independent, Libertarian, Peace & Freedom or other more obscure parties gravitate toward supporting Republican over Demo-

crats. While the vast majority of city's 170 Green Party members have proven out to be the one set of minority party members who support Democrats over Republicans, they constitute a mere 0.3 percent of Chino Hills' electorate.

In this way, Chino Hills is now, and has always been since its 1991 incorporation, a hotbed or Republicanism. All five of its current council members – Mayor Brian

Johsz, Councilman Ray Marquez, Councilman Art Bennett, Councilwoman Cynthia Moran and Councilman Peter Rogers – are Republicans. Like their predecessors, they have adhered to a fiscally conservative approach, seeking to balance the city's budget each successive year. Historically, the city maintained fiscal discipline, embracing conservative finan- *Continued on Page 7*

members of the board and the public as to what was represented as deficit spending and decreases in the district's reserves. Reserves are the accumulative amount of money an entity such as a school district accrues as a consequence of spending less money in a budget cycle than it receives in revenue dur-

ing the same budget cycle. While those reserves can be built up over the years as an entity such as a school district receives revenue in excess of its costs, in those years where the revenue diminishes or remains the same while operational costs increase above the amount of money coming in, deficit spending occurs. Deficit spending eats into a district's reserves.

Longshore, in the piece appearing in the *Daily Press*, said the

documentation provided to her and the other board members showed "reserves have decreased at a higher rate than the reported deficit spending: \$2,474,673.34 in the 18/19 calendar year, \$1,308,535.72 in 19/20, \$2,633,546.27 in 20/21, \$3,524,903.99 in 21/22, \$2,467,852.44 in 22/23, \$3,049,644.15 in 23/24, and \$98,500.18 in 24/25."

Longshore's characterizations of the district's financial picture were not accurate, the other board members

and the district's top administrators insisted. The turned to what they hoped would be a credible authority in countering Longshore's suggestions.

Seeking and obtaining a letter from San Bernardino County Superintendent of Schools Ted Alejandre in which he, essentially, expressed his opinion that there were no problematic issues with the Apple Valley Unified School District's finances. The letter, sent to Superintendent Nel-

son and dated February 3, 2026, stated "The county's fiscal oversight process, supported by the district's recent FC-MAT report and the last three annual audit reports have not exposed any instances of misappropriation of district funds."

FCMAT is an Acronym for the Fiscal Crisis and Management Assistance Team, an independent state agency in California that helps local educational agencies identify, prevent, and

resolve financial, operational, and data management challenges.

The ploy of having Alejandre vouch for the district, however, was of questionable utility, since Alejandre was himself mired in something of a misappropriation of funds scandal himself, one which involved his wife having worked, during much of Alejandre's tenure as county superintendent of schools, as the head of classified management *Continued on Page 5*

ment announced charges against five men – Tycen C. Proper, Bryan Omar Roa, Michael Alan Thomas, Daniel K. Eskridge and Abraham Hermosillo Alvarez - for an alleged plot to carry out an attack to kill government officials and others attending the Ultimate Fighting

Championship (UFC) Freedom 250 event held on the grounds at 1600 Pennsylvania Avenue in Washington, D.C.

The Federal Bureau of Investigation launched an investigation into the plot and identified a core group of conspirators who procured weapons and made plans to carry out the attack. The FBI made arrests over the weekend in Ohio, Missouri, Nebraska, and California.

"The investigation remains ongoing," the U.S.

Attorney's Office stated on June 16.

According to Acting Attorney General Todd Blanche. "The FBI, our law enforcement partners and our U.S. Attorneys did what they do every day to make America Safe through quick response and vigilance in investigating, disrupting, and dismantling this alleged plan before it could be carried out. We will take immediate and aggressive action to identify and prosecute those who in-

cite and plan acts of violence."

FBI Director Kash Patel said, "On June 10, FBI and our law enforcement partners became aware of a potential threat to the UFC America 250 event in Washington, D.C. involving individuals outside of the National Capital Region — and thanks to the rapid action of this FBI, our partners, and the Department of Justice in a multi-state operation, multiple individuals are now in custody and allegedly planned

attacks were stopped cold. While the result represented the best of investigative work, it was also nothing out of the ordinary for this law enforcement team — we are built to detect, respond to, and bring to justice those who threaten the lives of American citizens — particularly during large gatherings like the historic UFC 250 fight. That's exactly what we did here. I want to thank our great agents and partners. This work remains ongoing and we

mention that the home had been gifted to the couple by Scherer's LLC or the Newsoms' other financial assets. Reverse mortgage payments are not considered taxable income.

According to investigators who have looked at the couple's spending patterns, that money appeared to have been used to support their accelerated lifestyle.

No previous California governor, with the possible exception of Leland Stanford, spent money while in office at the pace, adjusted for inflation, that Newsom has throughout the entirety of his tenure, according to those looking closely into his finances. Virtually every California governor during the 20th Century, Gray Davis and Jerry Brown in the Third Millennium and even Arnold Schwarzenegger, whose Hollywood lifestyle carried over into his experience as governor, confined themselves to, if not frugal existences while serving as the Golden State's chief executives in their time, ones that were not overly extravagant. The Newsoms' expenses appeared to be spending nearly one million dollars on living expenses every three months.

Given that rate of spending and shortcomings in the Newsoms', and in particular Governor Newsom's, financial reporting, investigators have come to believe there is a "slush fund" put up by Newsom's friends, business associates and political supporters which he has been continuously tapping into.

In March 2023, the Silicon Valley Bank, where Newsom's PlumpJack Winery, Cade Winery and Odette Winery had their business accounts, failed.

In November 2024,

Newsom and his wife formed an entity, MHBD Farms, LLC, the name for which reflected the first names of their four children – Montana, Hunter, Brooklyn and Dutch. Two days later, MHBD Farms, LLC purchased a \$9.1 million 5,600-square-foot, six bedroom, five-and-a-half bathroom mansion at 224 Woodland Road in Kentfield from billionaire Daniel Pritzker, the heir to the Hyatt Hotels fortune and cousin of Illinois Governor J.B. Pritzker. The property, with its view of Mount Tamalpais, is situated on just under an acre, includes expansive floor-to-ceiling windows, an outdoor area with a swimming pool, a spa, a sculpture-lined garden and a guesthouse. The Newsoms paid 7% above Pritzker's asking price. Daniel Pritzker has been a major donor to Newsom's campaigns for San Francisco mayor, lieutenant governor and governor.

Questions have emerged in the media about the actual breadth and depth of the Newsoms' wealth, and federal investigators are now pursuing answers to speculation as to whether assumptions regarding that wealth and the Newsoms' assertions regarding it are accurate.

Since Newsom was San Francisco mayor, his involvement in the running of the companies he owns or has an interest in has been sharply limited. There have been conflicting reports as to the degree of his ownership/control of those entities as well as the income generated thereby. Similarly, Newsom's actual personal wealth has been a subject of dispute. In 2019, upon his installation as governor, all of Newsom's business holdings were placed in a blind trust.

Newsom's total assets were estimated to be, in the early stage of his political career, while he was a member of the San Francisco County Board of Supervisors but prior to becoming San Francisco mayor, in the neighborhood of

\$10 million, although that number zoomed to as high as \$30 million around the time he was elected mayor. Over the following two decades, the management of the business entities he held was left to others. Last year, there was a report that Newsom's assets, including real estate, had grown to a value of \$42 million. Despite Newsom's Democratic Party affiliation and political identification as an advocate of the common man, he has never disputed, and in fact has seemed to encourage, reporting that emphasizes his accumulation of wealth.

Nevertheless, it is difficult to effect a close, let alone exact, examination of his holdings based upon available documentation, insofar as that documentation is incomplete and has grown more so over the years that Newsom has been in office. Based upon what can be discerned from incomplete, elliptical and missing records and filings, it appears that Newsom's involvement in the business entities he is associated with is limited to a greater degree than is popularly assumed. Moreover, given the value of those entities and the number of investors and other principals in those companies, it appears the characterization of his wealth has been inflated in some instances and wildly inflated in others.

In 2025, Forbes estimated the stable of PlumpJack Wineries to be worth over \$400 million. The provenance of that estimate, and therefore its accuracy, has come under question. PlumpJack currently possesses nine active hospitality and lifestyle brand entities of varying worth in its core portfolio across Northern California. Newsom's percentage in each of those is not publicly available but one report is that his stake in one of those, at the low end, consists of roughly \$130,000 and at the high end, he has ownership shares that are valued at approximately \$1.1 million to \$1.2 million. In the ma-

majority of the rest, the value of what he owns consists of somewhere in the range between \$300,000 and \$600,000. It thus appears that the value of Newsom's business entities that come under the PlumpJack umbrella runs to no more than \$7 million and more likely to around \$6 million. Those assets are not liquid and generate a steady stream of income, which is distributed across the ownership of PlumpJack, of which Newsom holds only a minority percentage, believed to be no greater than 10 percent. Therefore, the value of those holdings would be immediately accessible to him only if he were to sell them. In making an immediate sale, he would likely have to accept selling them at a discounted price.

This explicates, investigators believe, why the Newsoms entered into a reverse mortgage arrangement with regard to the regard to the Fair Oaks property mere months after it was gifted to them. It also lends credibility, in the midst of reports of their expenditure of roughly \$3 million per year to support their lavish lifestyle, that a slush fund has been created for them by individuals seeking to influence state policy, and that the governor and his wife have been regularly drawing upon it.

Political donations are a way of life among elected officials in the United States, in California and elsewhere. It is not illegal for politicians to accept donations. Nor is it illegal for a politician to accept money from a donor and then engage in votes or the direction of policy that benefits that donor, as long as the votes made or action taken are not conditional upon the provision of those donations. In the instant investigation into Governor Newsom, prosecutors are exploring whether certain actions by the governor were in exchange for the generosity shown to him or his wife by those who benefited from those actions. Such an exchange of a donation or provision

of money for a benefit would constitute, under both federal and California law, a quid pro quo, otherwise referred to as a bribe or kickback.

Newsom who solicited \$450,000 from a Northern California tribe, the Federated Indians of Graton Rancheria, to fund his inauguration festivities, then hit the tribe up for another \$1.8 million donation to the California Partners Project. In 2024, the Newsom administration joined the tribe's efforts in court to block a rival casino from being built 15 miles away.

In 2023, Newsom inspired the legislature to pass and then signed into law Assembly Bill 1228, which exempted restaurants/bakeries commonly recognized as fast food establishments from the \$20 fast-food minimum wage increase. This applied most conspicuously to Panera Bread, which is owned by Greg Flynn. Flynn contributed \$164,000 to Newsom's gubernatorial campaigns and his effort to overcome a recall in 2021.

In 2019, when Pacific Gas & Electric was being faced with multi-million fines and costs for its negligence with regard to igniting wildfires, including the Camp Fire, Newsome promoted and signed Assembly Bill 1054, which created a \$21 billion wildfire fund, with California's taxpayers taking up half of that slack and allowing Pacific Gas & Electric and other electrical utility companies in California to pass the responsibility for the remaining \$10.5 billion on to their ratepayers. Subsequently, Pacific Gas & Electric donated \$200,000 to Newsom's inauguration and just under \$400,000 to Siebel Newsom's non-profit, the Representation Project.

Between 2018 and 2019, UnitedHealth donated a total of \$220,000 to Newsom's gubernatorial campaign and other political action committees he controlled. Newsom awarded \$492 million in contracts to UnitedHealth subsidiar-

ies in no-bid contracts and expedited arrangements.

A major issue discovered by investigators is Newsom's failure to make timely, and in some cases any, reports of donations provided to him directly and the California Secretary of State's unwillingness or failure to enforce the reporting requirements that apply to the governor. In certain instances, no reports were made. In others, the reports were filed belatedly. According to investigators, there were reports filed but they disappeared at some point from the public record, as was demonstrated when the documents were not available through the California Secretary of State's Office but later turned up through inquiries with the past treasurer of Newsom's campaign. At least some of that documentation appeared to have been hidden for a specific purpose, generally to prevent a connection being drawn between the largesse the governor had received and action his administration had taken to benefit those donors.

Last week, following contacts federal investigators had made with those in Newsom's circle – consisting of friends, donors, both business and political associates and state employees – the California Fair Political Practices Commission made a finding that the governor had failed to make a timely report of more than \$5.6 million in behested payments and fined him and his office \$31,500 for withholding that information.

A "behested payment" is a donation solicited from a donor by a politician, as in this case the governor, for purposes prioritized and explicitly earmarked by the politician. Those purposes can range from charitable purposes embraced by the politician to efforts involving charities of government agencies to redress challenges faced by an individual, groups of residents or cities/governmental agencies. In

for the San Bernardino County Department of Education, in which position she was provided with \$219,614 in total annual compensation. In 2021, Barbara Alejandre retired and began pulling a public pension which currently provides her with \$133,441.41 annually. Last year, as scrutiny of that circumstance at last caught up with Ted Alejandre, he decided to forego running for reelection as San Bernardino County Superintendent of Schools.

Rather than providing comprehensive line-by-line explications of what was actually in the budget and delineating what Longshore had gotten wrong, however, the Apple Valley Unified School Board, Nelson and other district administrators sought to instead make, for Longshore's ears and eyes only, what were essentially off-the-record, confidential and private reconciliations of the budget during closed sessions that were outside the scrutiny of the public.

Exactly how comprehensive and what the integrity of those demonstrations were is difficult to gauge, given the lack of public access to them. Longshore found them to be less than fully compelling, and from time to time made a point of saying so publicly. This further antagonized her colleagues

There appeared to be a fundamental disconnect between the school board majority and Longshore and her support network. Those in control of the district felt their status as elected board members and district administrators merited for them unquestioned faith in their integrity and rectitude of what they were doing in their official capacities. Longshore and her supporters, on the other hand, were willing to engage their trust only to the degree that Buchanan, Okpara, Roelle and Nelson were willing to

subject their activity to open public scrutiny.

After several months of increasing contretemps between Longshore on one side and on the other Buchanan, Roelle and Okpara as well as Superintendent Trenae Nelson and Nelson's assistant, Kilee Caudell, a resolution of censure against Longshore was drawn up.

The resolution highlighted that on October 30, 2025, Longshore publicly implied that the district engaged in retaliation against her, claiming that she did not receive health benefits due her as an elected member of the school board without first verifying the reason for the denial. According to the resolution for censure the modification of benefits was, in fact, a correction of a previous oversight and was applied to all board members. Raising the issue, the resolution stated, was a departure from the demeanor expected of a school board member.

According to the resolution of censure, on January 11, 2026, Longshore, while speaking as a guest on the Voice of Apple Valley podcast, incorrectly stated data relating to district staff departures and that the district was "losing staff to neighboring districts an alarming rate." According to the resolution, two days later, on January 13, 2026, the district made clear that recent staff losses. Took place because 43 teachers retired, seven moved out of state, five left for personal reason, two living outside the High Desert left for jobs closer to home, five left for career advancement opportunities in other districts or to community colleges, one left to work as a teacher in another local district and 12 were teachers released from probationary positions.

According to the resolution, Longshore had not adhered to the district's principles and

the board's bylaws and failed to speak with a "common voice about district priorities, goals, and issues."

According to the resolution of censure, on January 22, 2026, Longshore publicly accused a district employee

of failing to do her job without first personally verifying if her accusation was true. That accusation was false, according to the resolution of censure.

According to the resolution, on January 26, 2026, Longshore claimed that, "[o]ther than the spreadsheets I offered, this governing body has received no clarification on the budget or available funds and are now expected to make some very important decisions." The resolution states, "This is not accurate. District employees have repeatedly provided clarification to the Board on several budget-related matters.

The resolution stated that on March 5, 2026, Longshore accused the board of trustees of turning a blind eye to their responsibilities, stating that "[w]illful ignorance has been embraced while this board has been set against each other." This insulted Longshore's fellow and sister board members, according to the resolution, and violated the board's bylaw directive to treat everyone with civility and respect.

According to the resolution, on March 5, 2026, Longshore directly chastised her fellow board members, stating, "[a]s it stands, this Board, three strong, is closing its eyes, digging its heels, supporting and perpetuating a broken system." This violated the board's principle that required her to "[a]cknowledge that the majority rules" and "be supportive of this decision," according to the resolutions, which further propounded, "Even if Trustee Longshore does not agree with the majority on a decision, she must respect the will of the majority of the board and not allow her frustration to manifest into personal attacks."

The resolution charged Longshore of accusing her board colleagues on March 5, 2026 of "not understanding what they were approving, claiming, '[t]hree have sat as leadership on this dais, following this administration, giving direction to pay contractors taking steps to build a stadium, while hiring staff with temporary funds and spending down our limited reserves. Not because they understood the numbers, but because they were told to do so.'" According to the resolution Longshore "provided no evidence supporting her accusation that the Board did not know what it was approving," which constituted, according to the resolution "a groundless, public attack on her fellow Board members' credibility and adherence to governing policies."

According to the resolution, on March 5, 2026, Longshore claimed that district management's raise was, "unknown due to lack of transparency," resulting from the district not filing a staff collective bargaining pay arrangement disclosure document. According to the document, Superintendent Nelson's pay raise had been disclosed on another form she had submitted.

The censure resolutions charged Longshore with twice disregarding information provided by Superintendent Nelson and then blaming the superintendent for a lack of transparency.

According to the censure resolution, on April 2, 2026, Longshore referred to her board colleagues as a "mindless machine driven by misinformation, self-preservation, and a blind following with no paper trail to prove it." This gratuitously insulted her board peers, according to the resolution.

According to the resolution, on April 17, 2026, Longshore violated the Apple Valley Unified School District Governance

Handbook's site/programs visitations provision by entering a high

school campus without first providing advance notice to either the superintendent or the school's principal. This interfered with educational operations, according to the resolution.

According to the resolution of censure, on May 7, 2026, Longshore attempted to publicly embarrass Assistant Superintendent of Administrative Services Matthew Schulenberg by calling him out in an open session for not being able to answer a question, "on the spot." This violated the understanding that district board members not blindsided district personnel with questions asked in public and provided staff with such questions to be posed in advance of any public meetings.

According to the censure resolution, on April 10, 2025 Longshore questioned Superintendent Nelson about an action she took at the direction of the board stemming from a discussion in closed session. This put Nelson in the position of having to engage in a conversation in which the subject originated in a confidential exchange in a closed session, according to the resolution, and Longshore disclosed, or risked disclosing, information the public should not have been made aware of.

According to Buchanan, Roelle and Okpara as well as Superintendent Trenae Nelson Longshore is a blabbermouth who isn't smart enough to understand that sometimes the public can't handle the truth and that is why the citizenry must on selected occasions be kept in the dark. The board is, after all, according to Buchanan, Roelle and Okpara, a team and Longshore just isn't a team player. She is continually trying to bring the public in on information it would be better that was simply left unmentioned, as people with good sense normally let sleeping dogs lie.

At the June 11 meeting, Okpara said of past school board members, "I've never ever seen them go after each other. Never. Never observed

it."

Longshore had broken with that tradition, Okpara said, and needs to learn to express her differences with the board in the back halls of the district and in private, and make a show of agreement when everyone is looking on. What Longshore is doing, Okpara said "is painful for me to watch. I have never watched the board disagree to a point of throwing darts at each other. I'm not looking for everybody to get along, but I'm looking for everybody to respect each other.

Okpara told Longshore and Board Member Anita Tucker they need to apply mathematical calculation to the situation to recognize they are the minority on the board and she, Roelle and Buchanan are the majority. She said that when the board was reconstituted into its present line-up after the 2024 election, she met with Tucker and Longshore, instructing them to get with the program.

"I was very clear that we had a protocol here in Apple Valley: If we disagree, we disagree, but it is best for us to disagree behind the walls, so that when we come up here to talk that we're coming up here with a united voice, united face, united way of speaking," Okpara said. "We don't just throw darts without evidence, without facts." Okpara said she had encouraged Longshore to use her voice but that Longshore was doing so in a way that was offensive to her colleagues.

Ann-Marie Van Gordon, transitional kindergarten teacher at Desert Knolls Elementary School read a statement in support of Longshore that had been written by President of the Apple Valley Unified Teachers Association Karen Sabers. "I am the president of the Apple Valley Unified Teachers Association," Van Gordon quoted Sabers. "I stand in opposition with many to the proposed censure of Trustee Renee Longshore. Whether you agree with Trustee

this case, the California Fair Political Practices Commission focused upon a call Newsom had made for a number of entities, most of them companies or corporations, to assist in the recovery effort during and following the Los Angeles Wildfires, which began on January 7, 2025 and were not fully contained until January 31, 2025. Newsom, as governor, had proclaimed a state of emergency on January 7, 2025. Newsom sought financial assistance for the California Fire Foundation, a 501(c)(3) organization which supports firefighters and fire victims, and 36 entities responded. In response, Uber donated \$20,000; BlackRock threw in \$500,000; PayPal laid out \$250,000; DoorDash provided \$50,000; Sony Corporation America ponied up \$50,000; Uber Eats gave \$500,000; Lockheed Martin shelled out \$500,000; Kaiser disbursed \$100,000; the Chuck Lorre Foundation bequeathed \$1,000,000; the Anthem Blue Cross Foundation chipped in \$500,000; Clayco put up \$150,000; Target came through with \$200,000; Orrick requited \$19,735; Akin Gump Strauss Hauer and Feld LLP proffered \$50,000; the KPMG US Foundation remitted \$25,000; Apple rendered \$250,000; the Wachtell, Lipton, Rosen & Katz Foundation coughed up \$100,000; United Airlines bestowed \$50,000; the John & Marcia Goldman Foundation kicked in \$25,000; Verizon plunked down \$150,000; Universal Music Group handed over \$10,000; Annenberg Foundation footed the bill for \$55,000; Paramount Studios dug up \$100,000; Sony Pictures Entertainment defrayed \$7,100 of the California Fire Foundation's burden; D'Leon Consulting Engineers Corp forked over \$25,000; the Klarman

Family Foundation bore \$25,000 of the expense; United Airlines flew in \$25,000; American Express provided \$150,000; the Insurance Industry Charitable Foundation made a \$47,418 gesture; Levi Strauss & Co handed up \$25,000; Next Era Energy discharged \$50,000 of the California Fire Foundation's costs; Amazon floated \$200,000; AT&T phoned in \$100,000 and Estee Lauder reeked of \$225,000. Newsom and his office failed to timely file a behested payment report for all of these "contributions," along with some others.

The \$31,500 fine represented 18 separate fines of \$1,750 each.

The *Sentinel* is informed that like California Secretary of State, the head of the California Fair Political Practices office staff, Executive Director Galena West, and General Counsel David Bainbridge are concerned of the perception that as the state's top political watchdog, it failed to hold Newsom to account. The California Fair Political Practices Commission Chairman, Adam Silver, was appointed by Newsom. Fair oaks

Notably, when Scherer gifted the Fair Oaks estate to Newsom and his wife, complaints were lodged with the Fair Political Practices Commission, both before and after the ploy of utilizing the reverse mortgage to give the Newsoms a \$2.695 million tax-free infusion of funds, the FPPC concluded that what had occurred was a form of "money laundering," a violation of gift limits or improper in any way. At the time the purchase was made, Newsom still owed \$3.2 million on the home he had been living in previously. He subsequently realized a profit of \$2.7 million when he sold that property for \$5.9 million. Critics have

suggested the Fair Practices Commission was covering for Newsom because of his power position in the state.

Federal investigators are highly suspicious of the way the 2024 purchase of the Kentfield property was structured. The formation of the MHBD Farms, LLC was a legal dodge to avoid property taxes, gift taxes and reporting requirements. Where the Newsom's obtained the money to make the purchase is not clear, leading to an investigative theory that some entity unknown supplied the couple with money they have not reported. It would not appear that, based on income alone, the Newsoms, despite their wealth, could have qualified for a loan to finance the purchase of the property, especially given their other financial commitments.

Newsom is paid \$203,939.40 in base salary from the State of California for his role as governor, together with \$95,063.16 in benefits. He is due to leave that post in January 2027. Assuming his wife can maintain her yearly income of \$395,000 a year from the Representation Project and the California Partners Project after her husband is no longer in the position of governor to scare up donations to those entities, it would not appear the couple would be able to meet their mortgage payments.

The annual mortgage on the Marin County mansion property would run anywhere from \$330,000 to \$384,000 per year, together with an annual property tax bill of slightly more than \$117,000.

Of focus in the investigation is what quid pro quos or exchanges were made between Newsom and Li Ke, a Chinese businessman who transits between the People's Republic of China and the United States on a frequent basis.

Ke, the executive vice president of the China-based BYD Company and president of its sub-

siary BYD Americas, donated \$20,000 to Newsom's gubernatorial campaign in 2018. He made another \$30,000 donation to Newsom's successful 2022 reelection effort.

According to investigators, initial concern that federal law restricting donations from foreign nationals to American politicians had been broken was determined to have been misplaced when it was determined that Ke had a green card. U.S. law carves out an exception to the aforementioned restriction if the foreign national in question holds a green card, which allows that foreigner to donate to any federal, state, or local campaign or candidate.

Nevertheless, there have been questions about what Ke and BYD are actually involved in within the American business sector, with recurrent suspicions that either or both corporate espionage or military espionage were at play.

Newsom grew close to both Ke and BYD, and the BYD Americas has obtained over a billion dollars worth of U.S. and California government contracts. Those contracts involved BYD Americas being provided with sensitive information.

In 2023, Newsom traveled to Shenzhen, China, where he was received by Ke and other BYD executives and Chinese government officials at BYD's corporate headquarters. in 2023.

BYD is involved in the manufacturing of electrical vehicles, electronics and automotive components, rechargeable batteries and energy storage systems and public transportation and rail transit systems.

Li and her husband, BYD's billionaire founder and CEO Wang Chuanfu, are both members of the Chinese Communist Party and close associates of Chinese President Xi Jinping.

Within the last two-and-a-half weeks, the Pentagon formally classified BYD as a Chinese military company,

blacklisting it to restrict its access to a host of U.S.-developed technologies it was previously given access to.

Investigators are interested in learning what Newsom might have done to enhance BYD's access to sensitive corporate and military related technologies, potentially in exchange for money that was provided to him by Chuanfu through Li.

In November, Dana Williamson, who was once Newsom's chief of staff and the chief of staff of former Congressman and former federal Secretary of Health and Human Services Xavier Becerra, was indicted on charges that she was involved in a conspiracy to illegally funnel money from what at that time was Becerra's dormant campaign account to herself and others.

As federal investigators and prosecutors were closing in on her but before her indictment, Williamson, spoke with the US Attorney's Office in Sacramento, the *Sentinel* is reliably informed.

She was questioned intensely with regard to matters pertaining to Newsom. One such issue was the Newsom Administration's relationship with the gaming company Activision, against which the California Civil Rights Department had alleged featured a culture of sexual harassment and sexism before the matters was settled with the payment of a \$50 million fine.

It is unclear what information the U.S. Attorney's office might have wrung from Williamson during that questioning session.

On May 14, 2026, Williamson pleaded guilty to conspiracy to commit bank fraud and wire fraud, subscribing to a false tax return, and making false statements to a federal agent.

In preparation for his 2018 gubernatorial run, Gavin Newsom in 2017 pledged to release his tax returns. He has since walked that back, and investigators, in the words of one federal agent, have sensed that as "an

indication of blood in the water" and have consequently intensified their focus on what they have characterized as Siebel Newsom's hedging and underreporting/hiding of her actual income.

On Monday, Newsom released a four minute and 43 second video in which he acknowledged he and his wife are the target of a federal investigation.

It was the governor's contention that the probe is politically motivated, and that what is being orchestrated against him and his wife is merely an effort to prevent his ultimate progression upward from California's governorship to that of the nation's chief executive.

"In recent days, federal agents have knocked on the doors of family, friends, and former employees, not because they found a crime, because they're simply trying to find one," Newsom said. "They're demanding records. They're abusing the grand jury process, digging through years of random documents. Donald Trump isn't just coming after me because of my mean tweets. He's coming after me because I'm considering running for president, because he hates that I've consistently called him out over and over again because of his lies and deceit."

Newsom then hit on his major theme: If he, as California governor is a crooked politician, he is merely a piker in that regard in comparison to the president of the United States.

"Donald Trump is simply the most corrupt president in American history," Newsom said. "He's turned the levers of government into his own personal power ministries, to reward cronies and try to jail his opponents. His personal attorney now runs the Department of Justice, which has repeatedly gone after his political enemies. One by one, anyone who has challenged Donald Trump has ended up on his hit list. Today, I proudly join

UFC Freedom 250 hosted on the White House grounds.

According to filed complaints in the Southern District of Ohio, the Western District of Missouri, the District of Nebraska, and the Central District of California, investigators interviewed Proper at a medical facility on June 11. During the interview, Proper said that before executing the plan, he and other conspirators intended to rendezvous in Fredericksburg, Virginia, where they were to finalize a coordinated attack against the U.S. government during the UFC event at the White House. He said members of the group who wanted to participate in the attack began communicating with each other around March. More serious members of the group, including Proper, moved their communications to an encrypted chat app.

The conspirators allegedly planned to deploy drones armed with explosives in and around the UFC Freedom 250 event, detonate them over the north side of the UFC arena, thereby forcing high value targets to evacuate the premises, whereupon snipers would be deployed to fire upon specific individuals within the fleeing crowd.

Proper allegedly amassed firearms, thou-

According to the complaint filed in the Central District of California, law enforcement executed a search warrant of Roa's residence and vehicle where they allegedly seized a rifle, handgun, tactical belt, ammunition and a rifle magazine, a two-way radio, and an infrared laser target pointer. A search of Roa's phone allegedly found messages in a group with Thomas, Proper, and others discussing an attack at the UFC event at the White House, with some users discussing using drones rigged with explosives to initiate the attack, with rooftop snipers killing individuals. Law enforcement also allegedly found Instagram videos Roa had posted of himself shooting guns.

During his voluntary interview with law enforcement on June 11, 2026, Proper said that an individual with the online username "Whiskey Six Amerika" was one of the primary individuals involved in planning the attack at UFC Freedom 250 and that this individual provided information during the planning phases. During a review of Proper's

According to the complaint filed in the Central District of California, Thomas participated in a group chat planning the attack. In one chat exchange, on June 7, he wrote "\$1300 gets us the drones and the charges. Yes we should all pitch in and we need it asap..."

In another group chat, Thomas, using a pseudonym, described "tiers" of operators within the anti-government group, with tier 1 being operators on the ground, tier 2 being drivers and drone operators, tier 3 being logistical suppliers, and tier 4 being social media influencers. On May 23, 2026, Thomas characterized the tiers of operators, stating: "Tier 1 operators may be asked to put themselves in harms way, break the law, and potentially go into hiding. Tier 2 would consist of get away drivers, drone operators, and direct support. May still be asked to seriously break the law. Tier 3 may be

The "Hunters" Signal group, which included Thomas, Proper and other co-conspirators, contained detailed instructions for carrying out the attack at UFC Freedom 250, including plans to safely escape after the attack. Screenshots from Proper's phone regarding those plans extended to aerial photos and maps of locations in and around Washington, D.C. that included the White House and discussed where snipers should be

costs increase above the amount of money coming in, deficit spending can occur. Deficit spending eats into a district's reserves. placed and where drones should be launched.

On June 13, the FBI served a search warrant at Thomas' Pinon Hills residence and found a hunting rifle, an AR-style rifle, 30-round extended magazines for the AR-style rifle filled with approximately 180 rounds of ammunition, and a pistol. Additionally, Thomas spoke with law enforcement and admitted to helping plan the attack and encouraging others to take part in it.

Eskridge was charged with conspiracy to commit murder on White House grounds. According to an affidavit filed in the Western District of Missouri, the FBI identified Eskridge while reviewing electronic communications on Proper's cell phone. The co-conspirators had electronic chats on encrypted social media platforms. In those chats, members of the group allegedly discussed assassinating

related personnel costs. Its other option is to engage in borrowing to make up the difference between its revenue and its greater operational costs. an eventual reduction of the level of service and a shedding of staff and municipal personnel. If a city does not manage to return to operating on balanced budget and retire its debt, a very real possibility of bankruptcy looms for it as well as a potential that the city itself would be disincorporated, its municipal status revoked and its governance assumed by the county.

As noted, Chino Hills, in keeping with what are considered to be municipal management/operational practices and the fiscally conservatism associated with its predominantly Republican leadership, has historically functioned utilizing balanced budgets. Over the last several years, Chino

Hills has not been immune to rising costs and basic inflation which the rest of American society and California communities in general have been dealing with.

In recent months and weeks the entirely Republican Chino Hills City Council has been brought to understand the harsh financial reality facing the city. In the time before City Manager Benjamin Montgomery departed in March and over the last three months since Rod Hill has been city manager, Christa Buhagiar has been finalizing a spending plan for Fiscal 2026-27 that has pared back departmental expenditures in a way Montgomery and Hill believed was prudent and which the city's department heads indicated they could abide by. Despite those efforts, the ratio of income to outgo is anticipated to be a negative one. The best projections available as of early this

month were that between July 1, 2026 and June 30, 2027, the city can anticipate at least \$58.6 million and as much as \$59.4 million in revenue and that it will spend in the neighborhood of \$63.5 million. Consequently, city officials anticipate the city will run a deficit of somewhere between \$4.1 million and \$4.9 million in the upcoming fiscal year.

The city council is thus left with the options of 1) approving the \$63.5 million spending plan as laid out and making up for the difference between that figure and the actual revenue it will realize in 2026-27 by drawing from its \$25.4 million in available reserves or 2) imposing mandates on the city's department heads to reduce spending in their respective departments beyond what was previously discussed, leading to an inevitable drop in service levels to the city's residents;

of the entity they head to not only endure but intensify. Theirs is a commitment not so much to the individuals they represent but the city itself. The city is now being threatened with increasing operational costs and dwindling revenue with which to carry out those operations. Their Republican instincts to slim down the bloat of government in order to balance the city's books has been overcome by their promote the city as an agency of enhancement to the community.

An indication of the degree to which the city council's inclination toward streamlined governance has been compromised with each succeeding year its members remain in office exists in the manner in which it has made concessions to the employees at City Hall. Economic trends have been at play for years. The escalation in costs across the board did not initiate in the last six months. Despite bellwethers going back more than half of a decade indicating that cushion between municipal revenue and how much money was needed to run the city could not be maintained and a need to reduce costs rather than increase them was

an imperative, in 2024, the Chino City Council signed off on giving the city's cost-of-living and salary adjustment of 3 percent. The city's employees next received a 5 percent salary increase on September 1, 2025, with an additional 5% raise scheduled for September 1, 2026.

It is unclear, precisely, who broached the idea of a sales tax override in Chino Hills. Whether the concept originated with the council or with city staff, it appears that Chino's success with Measure V suggested to someone within the orbit of authority that a similar move could be made in Chino Hills. Indeed, the roughly \$11 million to \$12 million in revenue such a measure would bring in would, for several years at least, redress the city's looming cash flow problem.

For the city council, however, another problem existed, that being each one of them would run the risk of coming across as tax and spend liberals if they were to openly advocate for the sales tax override. Consequently, the burden of introducing the concept and mustering up support fell to senior staff, meaning Montgomery, while he was still in place, Buhagiar and ultimately Hill. It was Montgomery's decision to, rather than take on the risk of triggering a citizen revolt, go at the assignment obliquely.

In February, roughly a month before he left the city, he used his spending authority as city manager to retain the firm of

Fairbank, Maslin, Maulin, Metz & Associates, Inc. to conduct a survey into whether city residents perceive increased municipal spending as an acceptable means of enhancing their quality of life. The questions were mixed into a host of inquiries relating to city operations and the quality and competence of government and city employees. For good measure, the survey sought out what the surveyed residents primary concerns about public life and life in general.

The survey was undertaken without fanfare or public announcement, and did not require the knowledge or approval of the city council, as Montgomery's managerial authority allowed him to sign on for contracts of less than \$50,000.

Layered into the survey were revelations with regard to the city's financial trouble, but not in a way that took the issue head-on but rather suggested that was the case without stating that to me a fact. Those who have looked at the survey remarked that if it was intended to serve as an announcement of the city heading into financial straits, it was a curious approach, given that fewer than 450 of the city's 77,420 residents – slightly more than one half of one percent – participated in the survey, which the city paid Fairbank, Maslin, Maulin, Metz & Associates \$39,000 to carry out.

What was suggested was that Montgomery was hoping the survey

would provide an indication that approaching 50 percent of the population either supported the upping of the city's sales tax or at least was not strenuously opposed to it, which would have given him the cover to openly advocate that an item to that effect be placed on the ballot on November 3, 2026.

Since the questionnaire was commissioned by the city, most of its questions were polite and somewhat benign, eliciting answers that percentage-wise cast the city and its officials in a warm and positive light.

By a better than two-to-one margin – 58 percent to 24 percent – survey respondents ranked the city making positive progress and change as opposed to moving in the wrong direction. The remaining percentage offered no opinion or a lack of knowledge with regard to the city's performance.

Respondents evinced an overall approval of the quality of life in Chino Hills, with 46 percent accepting as “very accurate” the assertion that conditions in Chino Hill are superior to those in neighboring cities, with another 40 percent considering that characterization as somewhat accurate.

The survey sought and obtained what was a predictable response to residents' attitude with regard to a primary Chino Hills institution, the San Bernardino County Sheriff's department, which serves as the city's contract law enforcement agency. The city's

police force found approval by 74 percent of those surveyed.

Asked to rate the city council, survey takers gave the panel the thumbs up, an approval rating slightly behind that given to city government/local government overall, which stood at 68 percent.

The survey gingerly approached the issue of city finances by asking respondents to rate the accuracy of the statement, “The City of Chino Hills is facing a budget deficit.” The degree to which city financial issues were off the average resident's radar was shown by a substantial majority – 63 percent – responding that they had no knowledge one way or the other. It was the impression of 6 percent that there is no fiscal crisis looming in Chino Hills at all, while another 12 percent were under the impression that such a problem was unlikely. Twenty percent of the city's residents, however, gave an indication that the city was behind the eight ball in terms of its spending, with 13 percent stating the city was facing a budget deficit was “somewhat accurate” and 7 percent saying that was a very accurate statement.

While the residents surveyed did not express overwhelming confidence in the city's stewardship of the tax money it is already receiving, neither were they overly critical in that regard. One survey question pertained to the perceived accuracy of the assertion, “The City of Chino

Hills has done a good job of managing its finances.” More than one third – 37 percent – ranked that as a somewhat accurate assessment and 14 percent agreed wholeheartedly. A significant number, 29 percent said they didn't know, while 16 percent said they believed crediting the city with that level of performance was somewhat inaccurate and another 5 percent opined it as very inaccurate.

The Fairbank, Maslin, Maullin, Metz & Associates survey came closest to meeting Montgomery's objective of clearing the way for seeking voter approval of a city-wide sales tax hike with a survey response that showed a bare majority of 51 percent believed the city needed to enhance its revenues. A full 17 percent of respondents said the city had a substantial need for more funding and another 34 percent agreeing the city had some need to bring in more money. At the same time, over 40 percent of the survey respondents were skeptical of City Halls hunger for more money. More than one fifth, 21 percent, said the city had little need for more funding and one fifth, 20 percent, said there was no real need for the city to enhance revenue. Eight percent expressed no view one way or the other.

According to Fairbank, Maslin, Maullin, Metz & Associates there appears to be among Chino Hills' populace a “modest” though not *Continued on Page 16*

the track course, as taking the turns at too high of a speed poses a severe tipping hazard for heavy, multi-platform freight cars. overwhelming potential support for "more funding."
